**MIRMA REPRESENTATIVE KELLY BEETS TO REVIEW RISK MANAGEMENT GRANTS**

Kelly Beets advised MIRMA handles worker compensation, liability for police and workplace, and assists with employment practices. City of Fair Grove's police department and public works submitted paperwork for a grant and both were approved. The police department's grant was for the purchase of two body cameras, as well as a car camera combo. The grant covered 60% of the costs in the amount of \$2,697. Public Works' grant was for a blower to clear manholes and confined spaces. This grant covered 45% of the costs in the amount of \$517. The total of both grants was \$3,214.05. Beets also presented the City of Fair Grove with a plaque in recognition of participation in the associations Risk Management Awards Program.

**EMERGENCY MANAGEMENT UPDATE ON AUTHORIZATION OF ALARM TESTING PRIOR TO HERITAGE REUNION FESTIVAL**

Ted Wolf advised original plan was to test sirens earlier in week, but due to various issues that did not happen. Ted met with Tiffany and used the radio she had to trigger the alarm to ensure the radio worked. The radio malfunctioned triggering multiple sirens at a time. Ted contacted the vendor and he is checking to see if the issue is the software on their end or if Emergency Management's radio needs to be looked at.

Icenhower asked Ted when he got the radio and Ted advised it was either last quarter or quarter prior to that. Ted was asked if he went through the chain of command prior to testing and Ault advised Ted has authority to check alarm/radios. Icenhower advised it was voted prior by the Board to go through a chain of command to include Mayor, Chief of Police and on then on down. It was asked why this had to be done right before the festival rather than on one of the testing days as the unexpectedness caused upset and confusion with the citizens.

Danderson requested in future all Emergency Management's testing be conducted right after the County tests them on their scheduled Wednesdays. Ted agreed their timing was poor, but as far as doing Wednesday testing that is not always feasible as he works and is not always able to get away to conduct the testing. Ted did advise he notifies the fire department, police chief and school if they are in session prior to testing.

**Mayor Report**


