Maine Ground Water Association Director's Meeting April 11, 2022 Via Zoom

The MGWA Director's Meeting was called to order by President Jesse Goodwin at 7:09 p.m. with the following present: Justin Lanphier, Mitch Woodbury, Susan Smith, Scott Abbotts, Scott Hodgdon, Brian Streeter, Glenn Dyer, and Noah Rolfe.

Minutes: A motion by Brian Streeter and seconded by Justin Lanphier to approve the March 14, 2022, Director's Meeting minutes was unanimously approved with the following correction, delete duplicate Director's name Brian Streeter.

Treasurers Report: A motion by Scott Hodgdon and seconded by Justin Lanphier to approve the Treasurer's Report was unanimously approved.

Old Business: Discussion on drill rigs being overweight. Drill rigs are typically low milage. Most drill rigs are not in compliance. Scott Abbotts did some online research and found out how other states register drill rigs. Jesse Goodwin spoke with State Senator Jeff Timberlake. We should call our local state legislators to see if they can help us. We may be able to get a rule change or get a bill sponsored, but not until they're back in session. Jesse Goodwin formed a committee to work on overweight issue, consisting of Justin Lanphier, Scott Abbotts, Noah Rolfe, Scott Hodgdon, Jesse Goodwin, and Susan Smith. Committee will meet on April 25, 2022, at 7:00 p.m. Via Zoom.

Maine Ground Water Association Director's Meeting May 9, 2022 Via Zoom

The MGWA Director's Meeting was called to order by President Jesse Goodwin at 7:04 p.m. with the following present: Justin Lanphier, Mitch Woodbury, Scott Hodgdon, Susan Smith, Scott Abbotts, Brian Streeter, Noah Rolfe, Daniel Locke, and Randy Marquis.

Minutes: A motion by Brian Streeter and seconded by Noah Rolfe to approve the April 11, 2022, Director's Meeting minutes was unanimously approved.

Treasurers Report: A motion by Justin Lanphier and seconded by Brian Streeter to approve the Treasurer's Report was unanimously approved. Scott Abbotts reported that to date, we have taking in \$5000, there are 40 golfers signed up and 4-hole sponsors. He has also purchased items for the scramble.

Old Business: Scott Abbotts drafted a proposal for legislation on weight limits for well drilling trucks and tender trucks being overweight. Commission/Legislative Committee: (Frank Hegarty & Jesse Goodwin) Jesse report that The Commission is in the process of writing rules, points values, and fine dollar amounts. Trying to get fine val-

ues increased. Discussion on pressure tank sizing per manufacturer specifications. New language regarding Jaswell seals vs shale traps. Dan Locke reported on the matrix reduced setback table, that all wells are currently treated as a specialty well. They are in the process of clarifying a specialty well permit, is not needed, if you are greater than 60' from a tank/leach field, but you will still need to file the setback reduction form with the commission. Less than 60' from the tank/leach field, you'll need a specialty well permit approved and recorded in the registry of deeds. Also working to get the distance from the septic tank to be the same between the well drillers rules and site evaluators rules to be 60'. The current wastewater rules match our old setback table. Dan reported on the current Maine water level conditions. If you would like to search water levels in Maine you can google, USGS Maine you'll find stream and groundwater levels. Dan spoke of a well that he looked at from May 9, 2021, and 2022 and the water levels are almost the same. These wells are measured every 30 minutes. Chris Halsted is still with the Maine Geological Survey.

Proposed Legislation

The yellow box below is our proposed legislation that we added to the current legislation.

§2353. Weight limits

- **1. Weight limits.** Except as provided in section 2355, the following gross vehicle weight limits apply to vehicles operating on a public way:
- A. For a 2-axle vehicle, 34,000 pounds;

trailer, 100,000 pounds.

- B. For a 3-axle vehicle or combination of vehicles, 54,000 pounds;
- C. For a 4-axle vehicle or combination of vehicles and, except as provided by section 2364, for single unit vehicles of 5 or more axles, 69,000 pounds;
- D. Except as provided in paragraph E, section 2354, section 2357, subsection 4 and section 2365 for combination vehicles with 5 or more axles, 80,000 pounds; and E. For a combination of 3-axle truck tractor and tri-axle semi-
- **2. Weight reductions.** The maximum gross vehicle weight permitted for combination vehicles having:
- A. Four axles is reduced by 1,000 pounds for each foot the distance is less than 18 feet between the centers of the extreme axles, excluding the steering axle, measured to the nearest foot; or
- B. Five or more axles is reduced by 2,000 pounds for each foot the distance is less than 24 feet between the centers of the extreme axles, excluding the steering axle, measured to the nearest foot.
- **3. Exception.** Subsection 2 does not apply to vehicles operated on the Interstate Highway System.
- 4. Axle weight limits. The following axle weight limits apply.
- A. Except as provided in section 2355, a vehicle may not be operated with a gross weight exceeding:
- (1) On a single-axle unit, 22,400 pounds;
- (2) On a tandem-axle unit, 38,000 pounds; or
- (3) On a tri-axle unit, 48,000 pounds.
- B. A single axle of a tandem-axle unit may not support more than 60% of the total weight supported by that tandem-axle unit, unless neither axle exceeds the weight legally allowed on a single-axle unit of that vehicle.
- C. A single axle of a tri-axle unit may not support more than 40% of the total weight supported by that tri-axle unit.
- D. The maximum gross weight of a vehicle or axle may not be increased by the addition of an axle unless it supports at least 50% of the added weight permitted by its addition.
- **5. Maximum tire weight.** A vehicle may not be operated when the load on the road surface is greater than 600 pounds per inch of tire width, manufacturer's rating, except for:

- A. Farm trucks transporting potatoes directly from the fields to the place of storage or to a processing facility during the potato harvesting season; or
- B. A vehicle operating under an overweight permit issued pursuant to section 2381.
- A tractor, the propulsive power of which is exerted not through wheels resting on the ground but by means of a flexible band or chain known as a movable track, is not subject to this subsection if the portions of track in contact with the surface of the way present plane surfaces.
- 6. Exemption. A vehicle modified for the purpose of plowing snow is exempt from the weight limits imposed by this chapter when engaged in or enroute to or returning from plowing snow or in ice control. A vehicle modified for the purpose of plowing snow is exempt from the maximum tire weight provisions of subsection 5 at all times. Any fire-fighting vehicle with its proper equipment that meets the National Fire Protection Association standards is exempt from the gross and axle weight limits imposed by this chapter. Any vehicle engaged in emergency maintenance of a public way is exempt from the weight limits imposed by this chapter.
- 7. Exemption; farm vehicles transporting potatoes. A farm vehicle transporting potatoes from the field to a storage or processing facility during the potato harvesting season is exempt from the axle weight limits and axle weight tolerance restrictions imposed by this chapter, except for the weight limits imposed under section 2355. To be eligible for this exemption, the farm vehicle must be in compliance with the gross weight limits established in this chapter and must have at least 8,000 pounds on the steering axle. This exemption does not apply on the Interstate Highway System, including that portion designated as the Maine Turnpike.
- 8. Vehicles within maximum gross vehicle weight limits. Not-withstanding any provision of this subchapter to the contrary, if a vehicle that exceeds axle weight limits and axle weight tolerance restrictions imposed by this subchapter by less than 5,000 pounds is within the applicable maximum gross vehicle weight limit including tolerances, the fine imposed under this subchapter is reduced by 50%.

This subsection does not apply to vehicles traveling on the Interstate Highway System except that portion of Interstate 95 designated as the Maine Turnpike.

9. Well Drilling Rigs and Tender Trucks. A well drilling rig or tender truck travelling to or from a site where it is performing its intended use is exempt from the axle weight limits and axle weight tolerance restrictions imposed by this chapter, provided that the gross vehicle weight does not exceed the GVW rating established by the original manufacturer of the chassis. To be eligible for this exemption, the drilling rig or tender truck must purchase the overweight limit annual permit.

Any person who is active in the daily operations of a corporation, partnership, or sole proprietorship engaged in the groundwater industry in the State, that owns and operates water well drilling equipment, and shows proof of ownership in said corporation, partnership or sole proprietorship, subject to the limitation that only three such owners of stock, or only three members of a partnership, who do not have a Master Water Well Drillers license, may become a Contractor member.

If applying for Contractor Membership, please enclose a current copy of your State of Maine Master Well Drillers License or a copy of an IRS form listing the owners of the corporation, partnership, or sole proprietorship with proof of ownership with this application.

Employee Membership: Any person that is employed by a State of Maine Licensed Well Drilling or Pump Installation Company. Employee members shall be subject to these By-Laws and shall be entitled to all privileges of this Association except voting and holding an officer position (President, Vice President, Secretary, Treasurer), they may become a director. Employee members may be appointed to and serve on Committees. The one single Employee member that may be a director can vote on matters being discussed during the Board of Director's meeting but is not able to vote during general/special meeting business.

<u>Scientists, Engineers & Public Agencies:</u> Any person engaged in the supervision, regulation, evaluation, development, or study of the groundwater industry. These members shall be subject to these By-Laws and shall be entitled to the privileges of this Association except voting and holding office. These members may be appointed and serve on committees.

<u>Manufacturers & Suppliers:</u> Any person or company engaged in the business of supplying or manufacturing of equipment, materials or supplies used in the groundwater industry. These members shall be subject to these By-Laws and shall be entitled to the privileges of this Association except voting and holding office. These members may be appointed and serve on committees. The one single Manufacturer/Supplier member that may be a director can vote on matters being discussed during the Board of Director's meeting but is not able to vote during general/special meeting business.

<u>Associate Member</u>: Any person or company that is interested in the groundwater industry who is not eligible to become a member of another membership section. These members shall be subject to these By-Laws and shall be entitled to the privileges of this Association except voting and holding office. These members may be appointed and serve on committees.

<u>Honorary Member:</u> Persons of acknowledged eminence in the groundwater industry in the State of Maine, or those who have contributed a special service to the furtherance of this industry and association. Persons eligible for honorary membership shall be recommended for approval by the Board of Directors and will be accepted upon approval of a majority of the voting members at any regular or special meeting.

Dues will be payable upon the acceptance of this application and an invoice will be mailed. All other classes of membership will have to pay dues as determined by the board of directors.

All prospective Contractor; Employee; Scientist, Engineer & Public Agency, Manufacturer & Supplier; Associate or Honorary members shall complete a membership application which shall be reviewed by the Board of Director's. The President will appoint a committee to review and approve or reject the applications for contractor membership.
