Greetings Everyone!

I am happy to report that the NEC meeting was held on March 6th. It was the first ever Zoom meeting with 43 in attendance. Following are some items I need to share with you.

EFFECTIVE IMMEDIATELY - (For reporting purposes) - Donations of cell phone chargers and/or USB cords to hospitals, shelters, etc. will have an evaluation of \$5.00 each (no hours or mileage). This will be reported for Community Service.

Since elections are upon us and no rules have been written for what to do during a pandemic, National Parliamentarian PNP Heidi Dineen-Serpis gave us her suggestion. It is as follows:

If you are able to meet, then you would follow your regular procedures. The same nomination/election procedures can also be done over Zoom.

If your Auxiliary is unable to meet and you need to have nominations and elections by mail it is important to remember that all members need to be notified. A notice that nomination for offices is open and anyone interested in running should respond with their name and the position they are interested in running for by a specified date to the President. A document with the list of offices and ladies interested in running for those positions should be prepared. The President shall ensure that these nominations are mailed to all members before the annual meeting to allow time for voting by mail and establish a date that these are to be returned by. A place for voter's signature should be indicated, so that there may be some means of protection against votes being cast by other than legal voters. Voting by mail cannot be a secret ballot as it is necessary for the tellers to know by whom each vote is cast.

If possible, there should be at least two people (tellers) counting the ballots. They could be opened and counted over Zoom. Keep these ballots until after your next in person meeting.

Just a reminder, service reports from the Local Auxiliaries are due to respective Service Officer (in their hands) by May 8, 2021 in order for totals to appear in Convention (June) Book. Hoping to see everyone soon!
