## Freedom of Speech

Freedom of speech is a cherished right that both school staff and students enjoy, but rights are neither absolute nor limitless. As such, school officials may impose reasonable restrictions on the symbolic (i.e. wearing of t-shirts) and verbal speech of students, teachers, and school staff. Why? Because teachers and school staff have the power to shape the attitude of students' lives.

This shaping is of importance to the State. The State is responsible for the public education of our children. When a government employee is "on the clock" they are acting for the State, to an extent. But generally, your outside of work, unrelated to your work and concerning a topic of public importance, is protected by the First Amendment. Here comes another but; if school officials can show that your speech, even if made outside of work, could adversely affect school functions or your effectiveness as a teacher/staff, the First Amendment may not protect you.

It is not the intention of Seminole County Public Schools ("SCPS") to deprive any employee of his or her right to freedom of expression. It is, however, the intention of SCPS to reasonably limit speech that is disrupting to the learning environment, school board facility, work unit, or work site. As the political and social landscape of this country changes, please be mindful of your work environment when expressing your opinions and exercising your freedom of speech. Each and every one of you are looked up to by someone. For further information on the topic, please don't hesitate to contact me.
