Minutes of Mirfield Town Council Meeting

MTC20/2015 Chairman's Welcome and Remarks:

It was with great regret that Cllr Lees-Hamilton informed those present that a position on MTC had already become available since the election due to one of the elected councillors failing to complete his declaration of office before or at the 1st meeting following the election or request an extension via the clerk to the council or the mayor. Elected councillor Michael Hutchinson has been deemed to have vacated his position and therefore a casual vacancy has arisen in the Battyeford ward.

Following the annual meeting contact was made with YLCA who provided a detailed legal response in relation to this issue. Cllr Lees-Hamilton has detailed correspondence between YLCA and MTC. In light of this Cllr Lees-Hamilton proposed that Martin Haigh should be contacted with the above details.

Cllr K Taylor also added that Sharon Salvanos should also be contacted.

Cllr Lees-Hamilton read out a letter from Mr M Hutchinson dated 31/05/15 (Sunday) claiming to have not received any information regarding meetings subsequent to the election. This was disputed by Cllr Lees-Hamilton and said that all information was sent out by the clerk well in advance of the annual meeting. Every Cllr present confirmed they had received details within the 1st few days of the election results being published.

Cllr Benson asked the cost to the people of Mirfield of holding a byelection. Cllr K Taylor informed him that the cost of the whole election to the people of Mirfield was £25,000 and as there was 5 wards this made it around £5,000 per ward, although Battyeford having the largest number of councillors would have been slightly greater. Cllr Pinder checked that no contact had been made with either the clerk or the mayor by Mr M Hutchinson and this was confirmed by Cllr Lees-Hamilton

Cllr A Burton confirmed that both he and Cllr M Burton had been in to swear in front of the clerk prior to the meeting despite feeling unable to attend the whole meeting due to suffering from bronchitis.

Cllr J Taylor also confirmed that he and Cllr K Taylor had sworn in with the clerk in the same manner due to illness.

Cllr Tolson asked what the procedure would have been had Mr M Hutchinson been unable to attend but made contact. Cllr Lees-Hamilton said that the request would have been discussed by the Cllrs present and then a vote taken as to whether an extension to the time should be granted.

Cllr K Taylor confirmed that she had spoken to Mr M Hutchinson on the Sunday after the election in light of the potential voting misconduct in the Northorpe Ward, this had been done since she had no contact information for the Labour candidate in that ward at this time Mr M Hutchinson made no reference to request an extension to complete his declaration of office.

- 1. Benches Eastthorpe Gardens & Wards Cllr Pinder reported that the pea gravel in Eastthorpe Gardens had been thrown in "handfuls" at premises of The Print Workshop. This had resulted in at least a dozen holes in the windows and damage to the ventilation fan. Cllr K Taylor expressed annoyance at the cost of the work on Eastthorpe Gardens, citing a domestic patio at the property of Cllr Sibbald of greater proportions which had been carried out by a local Mirfield firm at less cost and called the work in the gardens "An absolute mess" Cllr Benson asked whether we were liable for the damage Cllr Guy asked whether there was any CCTV of the incident. Cllr Pinder confirmed that as part of his contact with The Print Workshop he had asked about receiving their CCTV footage and he would continue to liaise. Cllr Lees-Hamilton confirmed that it should have been flagged rather than gravel and she would go and look following the meeting and it should be returned to the next meeting. Cllr Bolt suggested MTC contacted the new bishop regarding the 99 year lease on Eastthorpe Gardens. Cllr J Taylor confirmed that this was Bishop Jonathan Gibbs and said he would pass on the contact details to all Clirs. Clir Bolt asked Clir Tolson to speak to the P.C.C. regarding this matter. Proposed by Cllr Bolt **Proposed** as the decision on benches has been delegated to Ward Cllrs, this should be sent to the clerk. Part of this decision is whether to have a picnic bench or a park bench Cllr K Taylor Seconded Vote: All in favour
- Estimate for wall mounted bins to public toilets Cllr Lees-Hamilton Proposed that this estimate should be returned for one in greater detail as to the costs of the individual components and brought back before the council once received Cllr Guy Seconded Vote: All in favour 20.05 Former Cllr Hamilton arrived
- 3. Letter from Mirfield Health Centre –Cllr Bolt **Proposed** the following reply "Mirfield Town Council has considered the issue raised and if the group would like to submit a grant application with

a costed proposal then the Town Council will be happy to consider it" Cllr J Taylor **Seconded Vote: All in favour** Cllr K Taylor commented whether the tone of the letter implied that the group with the members of MTC go out patrolling.
