## Article Summary

Members of DEC receive the *Journal of Early Intervention* and the magazine *Young Exceptional Children* and have access to professional development opportunities in webinars, conferences, and learning decks, as well as timely recommendations to articles and resources specifically relevant to young children and their families.

Dana Kamara, Katherine Walton, and Andrea N. Witwer explore "Socioemotional and Autism Sectrum Disorder Screening for Toddlers in Early Intervention: Agreement among Measures" The Journal of Early Intervention, Volume 42, number 4, December 2020, pages 359—380. They compare common measures of socioemotional functioning: The Ages and Stages Questionnaires: Social-Emotional (ASQ-SE, first edition) the Child Behavior Checklist (CBCL) and the Brief Infant Toddler Social-Emotional Assessment (BITSEA). They concluded that overall the measures did not have substantial agreement among all measures but there was substantial agreement between the ASQ-SE and the BITSEA and moderate agreement between the ASQ:SE and the CBCL, and fair agreement between the BITSEA and the CBCL. They also looked at agreement among measures in terms of specificity for ASD screening in hopes of reducing the testing burden on families. For this, they used comparison to the Modified checklist for Autism in Toddlers, Revised with Follow=up (M-CHAT-R/F). They found the BITSEA had substantial agreement with the M-CHAT-R/F. They recommend further study in larger, more diverse samples. They conclude there is a continued need to evaluate the sensitivity and specificity of these tools.
