JURISDICTION

- 1. - 3. The mental condition of Heath Stocks is in controversy and this Court can order a mental and or psychological examination of Stocks to produce a cooperative forensic examination that was previously unavailable to this Court. The previous forensic examination was tainted because Stocks's defense counsels Mac Carder and Edgar Thompson advised Stocks not to cooperate with the forensic evaluation. See Petitioner's Writ of Error Coram Nobis, Ground Seven at page 24; Petitioner's Exhibits to the Writ of Error Coram Nobis No. 50, 51, 52, and 53 at pages 487-493 and Ex. No. 6 page 99-101.
- The perusal of the exhibits would give this Court a sufficient factual basis upon which to 4. grant this motion and Stocks is agreeable to take the mental and psychological examination.

WHEREFORE, Stocks prays that this Court grant his motion for the psychological and mental examination.
