INFORMATION FOR SCHOLARSHIP APPLICANTS

The Berks County Golf Association Scholarship award is granted annually through the BCGA. The BCGA Scholarship Committee considers numerous factors in determining our scholarship recipients. These include, but are not limited to:

Academics, character, leadership and service, golfing accomplishments, participation in our BCGA events, letters of recommendation, application information, financial need and acceptance into a post-secondary institution.

SCHOLARSHIP CRITERIA:

- High school seniors or current college undergraduate students are eligible. Club affiliation is NOT a factor.
- Applicant must be a resident of Berks County or parent(s)/guardian must be a member of a BCGA Member Club (Full or Associate)
- Applicant must have a high school or college cumulative GPA of at least 2.5 on a 4.0 scale.
- Applicant must have played regularly on their high school golf team's scheduled events.
- Applicants must demonstrate leadership skills and/or community service work.
- Applicants demonstrated financial need will be considered.
- Applicant must have applied to and been accepted into an accredited four-year, two-year or PGM academic program

AWARDS/RENEWALS:

Awards become effective with the fall semester of the year the award is made. Scholarship will be awarded in the amount of \$500. Funds are applied to educational expenses, including tuition, fees, books, and room and board. Checks will be made payable to the student upon receipt of college/university Enrollment Certification form.

Scholarship awarded can be renewable for up to four years, or until the bachelor's degree is earned, which ever is earlier. Renewal forms and instructions will be mailed to recipients from the BCGA Scholarship Committee. Recipients must maintain a cumulative GPA of 2.5.

Distribution will be no later than Sept. 1st, after receipt of grades and enrollment status.

In the event of serious malfeasance, breach of traditional conduct, or conduct involving moral turpitude, a scholarship may be terminated at any time within the discretion of the BCGA, whose decisions are final.

APPLICATION CRITERIA:

All applicants must submit the following:

1. Completed BCGA Scholarship Application Form.
2. **Letter of Application/Essay:** Each application must be accompanied by a letter from the applicant, outlining, (1) academic achievements, leadership and/or community service work and (2) golf experience (how golf has been an integral part of your life). The Scholarship Committee is also interested in the applicant's background and career objectives. This letter should include the applicant's personal and professional (academic) goals and how this scholarship will be of assistance. *(Letter must be between one to two typed page, size 11 font, single-spaced)*
3. **Transcripts:** Each applicant must submit (1) an 'Official High School Transcript' (through the last marking period) If currently in college, submit an 'Official College Transcript' following the Spring semester.
4. Three (3) letters of recommendation are required to support the application. Letters from the following individuals must accompany the completed application form.
 - a. Golf related (ie. High school coach or golf course/club junior golf program director or instructor)
 - b. High school teacher, counselor or principal or college professor.
 - c. Local community representative or business leader. (this individual may not be related to the applicant)
5. Optional: For consideration of financial need, please submit a copy of your official Student Aid Report (SAR) listing the Expected Family Contribution (EFC). This report is based on the processing results of your completed ***FAFSA (Free Application for Federal Student Aid)*** form. The deadline for filing the FAFSA for Pennsylvania is June 30, 2018. If you have not done so, please apply online at www.fafsa.ed.gov or call 1-800-433-3243.
NOTE: Mailing the FAFSA form usually takes 4-6 weeks for processing. Online submission is much quicker.

Scholarship recipients will be notified by mail.
