**Entry Fees:** Pre-entry PT \$10.00/Individual Elements \$20.00. Pre-entry must be received by May 11, 2019

Day of Show entries: PT \$15.00/ Individual Elements \$25.00  
Refunds offered for injured or sick dogs, or bitches in heat.

**Entry Eligibility:** All dogs must be permanently registered with UKC (Permanent Registration Number, Performance Listing, or Limited Privilege number) or have a Temporary listing (TL) number in order to enter. Dogs must be 6 months of age by day of event. An unentered dog may not be substituted for an entered dog.

Dogs which have passed NACSW Odor Recognition Test in lieu of UKC PT's must submit proof of their ORT's. Please include a copy of the dog's NACSW Passbook which shows the ORTs or print off the dog's records from the NACSW website.

Submitting Entries: Entries must be submitted on the current official UKC Nosework Entry Form. The new UKC Nosework Entry form is available at <https://www.ukcdogs.com/docs/showforms/nosework-entry.pdf>. Downloaded copies or photocopies of these forms may be used as well. Incomplete entries will not be accepted. Mailed entries must include the entire form and be signed.
