#### From the Desk of the Police Chief


Greetings residents of Franklin Township, the holiday season will be upon us in no time. Here are a few tips to remember;

- Have packages delivered to an address where someone will be or have a trusted neighbor keep an eye out and pick them up.
- Do not leave packages or personal items like purses or phones visible in your car while you shop.
- Be on the lookout for suspicious persons in the neighborhood that appear to be up to no good, it's always better to be safe and just call the police to have it checked out. Always be vigilant and God Bless

**Speed Cameras:** Franklin Township is currently using the speed camera technology to enforce violations in the school zones only, remember to watch for the yellow flashing lights. If you're not sure if the school zone is active you should drive at 20mph.

#### From the Desk of the Road Superintendent





Rake all leaves out into the grassy easement area near the edge of the road (between street and sidewalk where applicable).

Keep all leaves out of the street and away from storm drains.

Do not pile leaves around mailboxes, utility poles or fire hydrants.

Do not mix tree trimmings with leaves as this will damage the equipment and clog the leaf vac.

Do not mix building material with leaves.

The Township will collect leaves in bulk piles or PAPER YARD BAGS only. Leaves will not be collected if placed in plastic bags, or trash bins.

#### **BRUSH COLLECTION**

Brush collection will continue throughout the week, please call 614-279-9411 ext. 1 to leave a message with the address of where the brush can be picked up.

#### **SNOW REMOVAL**

Successful snow removal is contingent upon many things and the Road Department needs your help.

Please help your Road Department to properly and safely clear the snow from the roadway by parking all vehicles off of the roadway prior to an upcoming snow event. We ask that everyone pay close attention to weather forecasts and changing weather conditions. If you live in a curbed area on the side of the street where there are signs posted stating "No Parking During Snow Event" we ask that you abide by these signs. Your cooperation will avoid a citation and towing. Vehicles are towed at the owner's expense.

We all take pride in how clean and safe our township roads are during a winter weather event, and your help and cooperation is greatly appreciated.

#### A New Salt Barn Coming Soon

The Township is working diligently to beat the winter weather by contracting to have a new salt barn built at the south end of the Township property on Frank Road. This new building will be able to store more salt and be more efficient than the existing building. Much thanks to your Road Department for their contribution in making the salt barn possible.

#### From the Desk of the Fire Chief



Greetings from your Fire Department: I hope everyone has had a fun and pleasurable summer. Now that summer is winding down and we are getting ready for the fall and winter seasons, I would like to talk briefly about the Ohio Open Burning Rules.

When I took office over four years ago I decided that the Fire Department did not need to be issuing "Burning Permits". My decision was based on the fact the township does not hold the ultimate authority on open burning. The regulations are based primarily on the Ohio EPA regulations. There are two categories of the Ohio EPA regulations that affect Franklin Township residents and the two fires we get questioned about most often. The first concern is residential waste fires; the below guidelines are the proper ways to burn rubbish:

#### Residential Waste Fires are permitted as;

- Plant matter such as tree trimmings, stumps, brush, weeds, leaves, grass, shrubbery and crop residues.
- Also wastes such as wood or paper products that are generated by one-, two-, or three-family residences.
- Fire must be more than 1,000 feet from neighbor's inhabited building.
- Request permission from Ohio EPA if pile greater than 10 ft. x 10 ft. x 10 ft. This may take two weeks

Information on the PROPER way to have an outside fire is below:

<u>Campfires and Cookout Fires</u> (No notifications to the EPA is required outside of city limits)

- Wood stack no larger than 2 ft. high x 3 ft. wide.
- Use clean, seasoned firewood or equivalent.
- Any open burning shall be attended the entire time and shall not last more than 3 hours.
- Fires shall not be within 50' of any structure OFC 307.4.1
- For more information on Opening Burning see http://www.epa.ohio.gov

The Fire Department does have the authority to extinguish any fires that do not follow the Ohio EPA Rules or any fire that becomes offensive or objectionable. *OFC 307.1* 

Although the township does not issue the penalties, the Ohio EPA has strict penalties if they get involved with open burning complaints. The penalty could result in an "Unclassified Felony" charge and up to a \$25,000 fine.

Also remember if you need to get rid of tree branches or cut trees, the township Road Department will pick these items up at the street. Call the Township Office to schedule a free pick up at 614-279-9411!


