### **REGULAR MEETING**

### MASSAC COUNTY HOUSING AUTHORITY

### April 22, 2019

Members of the Massac County Housing Authority Board of Commissioners met in regular session on April 22, 2019 at the Spence Apartments office in Metropolis, Illinois. The meeting was called to order by Board Chair at 6:00 pm and upon roll call those present and absent were as follows:

There being a quorum present and the meeting duly convened by the chair, business was conducted as follows:

Upon a motion by Commissioner <u>Staton</u> and seconded by Commissioner <u>Parker</u>, and a roll call of ayes from Commissioners Burnett, Staton, Cromeenes, Eskridge, and Parker, the March 25, 2019 meeting minutes were approved.

It was moved by Commissioner <u>Eskridge</u>, seconded by Commissioner <u>Staton</u>, and approved by a roll call of ayes from Commissioners Burnett, Staton, Eskridge, Parker, and Cromeenes that payment of the following bills be authorized from funds of projects IL 41-1 through 9: (March 22, 2019 -April 18, 2019).

Financial reports were available for discussion. Commissioners examined bank reconciliations for all accounts. Commissioners Eskridge had a question about the cap on reserves before HUD would recoup funds from the authority. Commissioner Burnett had a question about the extraordinary maintenance. This expense was overtime for maintenance. Commissioner Burnett also questioned what the reasoning for the negative balance on the FY19 income/expense report is.
