Meeting Minutes

1. Call to Order

Kari Rader called the meeting to order at 10:05 A.M.

2. Roll Call

3. Additions or Deletions

4. Approval of the Agenda - ACTION

Chris Sheridan made a motion to approve the agenda. Vice Mayor Don Hendershot seconded the motion. A roll call vote was taken. There were no abstentions or objections. The motion was approved.

5. Consent Calendar – ACTION

5.1 Approve September 27, 2023, HFS CoC Meeting Minutes

Brandon Wirth motioned to approve the meeting minutes. Chris Sheridan seconded the motion. A roll call vote was taken. Amanda Russell, and Tamara Colden abstained. There were no objections. The motion was approved.

6. Standing Agenda Items

6.1 Veterans Services Update

There were no updates.

6.2 Committee/Work Group Updates

6.2a Coordinated Entry System Committee

DeAndre Richard stated the next meeting is December 6, 2023 at 10 a.m. and encouraged conversation about the rapid rehousing to permanent supportive housing process. DeAndre Richard also discussed the positive outcomes from the most recent case conferencing and the progress from community involvement.

6.2b Governance Committee

John Eckstrom reported that the next meeting would be on December 7, 2023 from 10 a.m. to 12 p.m.

6.2c HMIS Users Committee

Reneé Parham reported that the next meeting would be December 7, 2023 from 1 p.m. to 3 p.m. and encouraged all HMIS Users in Solano County to attend.

6.2d Lived Experience Committee

Joey Carrizales stated that the committee is doing outreach, and discussed the logistics of opening the meetings to the Spanish speaking community, but that there were some concerns regarding who would lead the meetings in Spanish at this time, Joey Carrizales invited those interested to the Public Meeting on December 5th.

6.2e Youth Advisory Board Core Planning Work Group

Akon Walker stated that the group was glad to have established some funding for further progress on establishing the YAB and are wrapping up the focus groups for the year. Akon Walker shared some of the feedback from the youth after the last focus group, including but not limited to having someone available to talk to before they became unhoused, having places where they could be away from some of the things they were experiencing, like youth centers, etc., and having more youth shelters in the community. Akon Walker also stated that in December they would be working with those who have expressed interest in being part of the YAB.

Katie Ward added that Solano County Probation is also working with Akon Walker in connection with youth voices in multiple different facets and that they have stipend dollars to help broaden the opportunities.

6.2f CA REAL Core Team

Kari Rader stated there would be a presentation later in the meeting.

6.3 2024 Point-In-Time (PIT) Count

Becky Farris stated that the registration portal is live: <u>https://solano24.pointintime.info</u> and asked for volunteers to sign up online and they are looking for people to provide "Known Locations" in advance of the count. Becky Farris shared the Jurisdictional Leads and that there would be a Community Planning Meeting on November 29, 2023 at 10:30 a.m.

7. New Business

7.1 Upcoming 2024 CoC Elections and Board Member Reminders

Reneé Parham stated that there would be an election for CoC Officers for the upcoming year and showed the current Officers and Board Members Terms as well as announced the term end dates and upcoming Board Member elections in 2024. Kari Rader and Tara Beasley-Stansberry are both on their 2nd year as Officers and could run for one more year before having to take a break as outlined in the Governance Charter. Reneé Parham announced that Joey Carrizales has resigned from the CoC, and the Lived Experience Committee effective December 2023 and would continue to serve on the CES Committee until his term ended as Co-Chair. Reneé Parham shared the <u>Google Form</u> for those who are interested in running for an Officer Position on the Board.

Reneé Parham shared the Conflict of Interest Statement that needed to be signed for the upcoming year and requested Board Members to check their emails and submit their forms.

8. Presentations

8.1 Racial Equity Improvement Project

DeAndre Richard presented the <u>California Racial Equity Action Lab</u> <u>Community Presentation</u> highlighting the goals and timelines for the changes in Solano County that will be incorporated in the upcoming years.

8.2 City of Fairfield Housing Authority

Tanya Tran from the City of Fairfield Housing Authority presented information regarding the Tenant Based Rental Assistance (TBRA) Program, which is a program for homeless individuals and families in the city of Fairfield, limited to 30% area median income or less. Those who qualify will be referred by the Homeless Intervention Team, pass a sex offender background check, be an eligible citizen of the United States, and are already receiving services or agree to receive services. The TBRA Program has a 24month maximum assistance limit during which time eligibility will be reviewed after 12 months and upon completion of the Program the participant can be placed on the Housing Choice Voucher waiting list, with a high preference for placement.

LaTanna explained that the City of Fairfield does not currently have a Move On Program and so they have made adjustments to the TBRA Program to assimilate what other communities have by means of a Move On Program for the unhoused, and that they are working to get more programs going to help with permanent supportive housing.
