The pop up food vendors attracted positive attention too. All sorts of delicious food items were available this year at Maifest, but we can't help but mention that the Amana Heritage Society's traditional Wurst, Obstkuchen and potato pancake stand was exceptionally busy and may have dished up the best potato pancakes in the history of the pancake. Kudos to these dedicated volunteers for frying their hearts out at festivals!

Swell Start to Great South Amana Swap Meet

"I couldn't be more pleased with our first event," said Tom Johnson, South Amana. He and wife Meg Merckens are founders of the Great South Amana Swap Meet which will continue on Fridays and Saturdays through October 6.

About 300 people attended the first ever South Amana market with 14 vendors Friday and 12 vendors on Saturday. Goods for sale included antiques, collectibles, furniture, tools and "rusty metal stuff" suitable for your garden art creations, Johnson said. Admission is free to the market and music.

As the season progresses garden produce and fresh eggs may be added as Johnson said that he's gotten calls from locals hoping to bring their farm / garden produce to sell.

Located in the barn and outbuildings in northeast corner of the village (by the Post Office) the market is open Fridays 4 to 8 p.m. and Saturdays 8 a.m. - 1 p.m. The area features a nice-sized stage placed in the shade with room for you to sit and enjoy the music. There are public restrooms at the market. The performances will happen on Friday evenings only, but there will be food and drink for sale on both days.

This Friday (May 11) the River Bottom Ramblers bluegrass band will be performing. The Ramblers may one of the top bluegrass bands in the state! There is entertainment lined up for almost every Friday night through August and Meg Merckens has dubbed this the "South Amana Summer of Music."

We are really looking forward to the toe-tapping, neighborly fellowship in South with upcoming performances by the Great Bluegrass Herons (May 25), Bob and Kristie Black and Banjoy (June 8), Marc and Brandi Janssen (June 22) just to name a few. Randy Sandersfeld was there Friday night and we are hoping to see him return later in the summer and pick up those TBA dates. The music will start at 5 or 6 p.m. and the performers will be play 2 hours or so.

Sandwiches, snacks, beer and soda will be available Friday evening and coffee, breakfast sandwiches, luncheon sandwiches and beverages will be sold on Saturdays.

Last week freshly grilled, hot bratwurst on a nice bun topped with a generous helping of red kraut or sauerkraut was the mouthwatering menu item and then on Saturday morning Ashley Beltz of Serena's served her tasty breakfast burritos, delicious coffee and more. Look for the menu to change as the chefs mix it up, but good food, good music, bargain shopping and neighborhood fellowship will make for pleasant weekends in scenic South Amana.

June 5 Primary Election Crowded for County Supervisor Post

A crowded field of contenders is making a run for the Iowa County Board of Supervisors. Yard signs are popping up like dandelions around the county and several candidates appeared or had floats in Saturday's Maifest parade in Amana.

The primary election is Tuesday, June 5, hence the ramp up, but you can vote now at the Iowa County Auditor's Office (located in the annex across from the Courthouse in Marengo). The Auditor's Office is open for voting Monday through Friday 8 a.m. until 4:30 p.m. Or you can vote early on Saturday, June 2 from 9 a.m. – 5 p.m. at the Auditor's office in Marengo. You can also request an absentee ballot by mail by filling out the form on the www.co.iowa.ia.us website and mailing it to the auditor's office as per instructions on the form.

The polls will be open June 5 at the normal general election polling places, 7 a.m. until 9 p.m.

There are 8 in the Republican field of potential nominees all vying for a chance to run in the fall. They will have to be tops on primary day to get onto the ballot. So the June 5 election is key for these office seekers.

There are no Democrats running in the June 5 primary. Running for Iowa County Supervisor in the June 5 primary election: Mike Curry, Marengo Iowa; John Gahring, Homestead, Bruce Adams, Williamsburg, Vicki Pope, North English, Alisha Shafer, Ladora, Alan Schumacher, Marengo, Kevin Heitshusen, Williamsburg and Tim Holloper of Ladora.

Kevin Heitshusen, Vicki Pope and John Gahring are the incumbents.

All of the other county offices have only one name on the ballot in this primary election. They are as follows: Tim D. McMeen, Williamsburg is running for Iowa County Attorney as a Republican; Sherry Pope is seeking re-election as the Iowa County Recorder and Michelle Sims, Marengo is seeking re-election as Iowa County Treasurer. Pope and Sims are both Republicans.

- One of the most important tasks of a board of directors is to select the leader of the company, and that task is before the Amana Society board of directors this year with John Peterson's announced plan to retire no later than this coming October. I believe my business background and my experience with hiring people can be of real benefit.
- I've been a businessman for many years, including 25 years as CEO of Stamats, a national media and marketing company. Like John Peterson, I am planning to retire this year. I've still got some good energy in me, and I think I can apply that to the benefit of the Amana Society as a director for the next three years.
