Any first time transfer student (valid change of residence (206.C) is not considered a transfer) is subject to the Sit Out Period (first transfer only; date differs per sport (207.B(5)) unless:

- *Student/ school is only requesting to compete Frosh or JV for the entire season (Limited Eligibility 207.B(5)a)
- *Student has not participated in a sport in the previous 12 months at the former school (Non-Participation 207.B(5)c) *Student qualifies for a Hardship (207.B(5)c(vii)) supporting documentation is required
 - 1. Divorce in the family
 - 2. Court-ordered Transfer
 - 3. Documented School Safety Issue
 - 4. Foster/ Homeless Children

Note:

- The sit out period is <u>not</u> an option for any student transferring for a second time. A second time transfer student (used sit out period already) is <u>ineligible for one (1) calendar year</u> from the date of transfer in any sport they have participated in, at any level, in the past 12 months at the former school.
- Transfers due to disciplinary issues at the previous school will be ineligible in all sports for one calendar year from the date of transfer.
