Chief Kenneth Preston explained that when the Police Department flooded last year. The initial bid was for \$23,000.00 to install wood laminate flooring throughout the entire office. After discussion, Mr. Archer and Chief Preston decided that it would be more palatable to put wood laminate flooring in the hallways and carpet squares in each individual office. The bid to do that is from McClure Building Co. for \$17,095.00. Chief Preston described the work that the staff has done on the offices to make a more professional environment, including cleaning, organizing, and painting in the entire department and is requesting the Council to approve the expenditure to continue improving the look and morale of the department.
