Potholes

Did you know that Fairfax County Government has a new interactive map that displays who owns which roads in the county? Viewers can easily find out who owns what roads. There are about eight organizations in our county that own the roads. Use the link,

New Noise Ordinance Passed

Effective February 17, 2016, there will be a new noise ordinance in place that impacts late night parties and early morning leaf blowing. This new county code replaces the previous noise ordinance. Here is a highlight of some of the new rules. For a complete list, visit http://www.fairfaxcounty.gov/news2/new-noise-ordinance-passed/

- The law prohibits noise during specific hours.
- Operating **power lawn equipment, including lawn mowers**: (a) between 9 p.m. and 7 a.m. when operating the equipment within 100 yards of a dwelling; or (b) between 9 p.m. and 6 a.m. when operating the equipment 100 yards or more from a dwelling...However, on all properties, the operation of leaf blowers is prohibited between 9 p.m. and 7 a.m.
- Making noise that can be plainly heard in another person's home with the doors and windows closed between 10 p.m. and 7 a.m. Sunday through Thursday, or between 11 p.m. and 7 a.m. on Fridays, Saturdays, and the day before a federal holiday.
- Barking, howling, meowing, squawking or quacking animals between 10 p.m. and 7 a.m. when it can be heard inside a home with its doors and windows closed, or if these sounds can be heard 7 a.m. and 10 p.m. for more than five minutes consecutively or non-consecutively during a 10-minute period.

New Rules for Dog Tethering Passed

Tethering a dog for more than one cumulative hour during any 24-hour period, unless the dog is under the direct supervision and control of its owner or custodian, is now prohibited in Fairfax County.

Stay Vigilant; Report Suspicious Activity!

In light of the recent events in Paris, we want to remind you that we all can help protect our community. One key way is to be aware of your surroundings whether in our neighborhood, at the grocery store, at work, on the roads, etc. Remember, "If you see something, say something."

Virginia has an organization, the Virginia Fusion Center, that brings together federal, state and local officials to share resources, and information to help identify, detect, prevent and respond to terrorist and criminal activity. Items you may see that you may want to report are:

- Unusual interest in facilities or infrastructures beyond the casual or professional interest.
- Purchasing/stealing explosives, weapons, ammunition, etc.
- Suspicious transactions involving large cash payments, deposits, or withdrawals.
- Purchase and/or storage of unusual quantities of materials, like cell phones, pagers, fuel, chemicals or toxic materials, and timers.

Safe Trade Zone

The Herndon Police Department has set up a "Safe Trade Zone" for use by the public as a meeting place to complete online transactions in the parking lot of the Herndon Police Headquarters at 397 Herndon Parkway, Herndon, according to a Herndon Police Department announcement. The area is well lit and monitored by security cameras. Transactions may also be completed in the lobby of the police station, which is open 24 hours-aday, 7 days-a-week. Members of the police department are not available to provide legal advice, nor settle disputes or act as witnesses to transactions. The Herndon Police Department says it cannot guarantee the quality or authenticity of items purchased online. Be cautious of someone who is hesitant about completing a transaction in a "Safe Trade Zone." It may be a warning sign not to conduct business with this person. Chief Maggie DeBoard said, "We want the public to feel safe while conducting online transactions and a Safe Trade Zone offers an excellent location for people to complete the process without worry."
