Mayor Gary Davenport called the meeting to order: 7:48 p.m.

A motion to approve the consent agenda was made by Pro-Tem Reed and seconded by Councilor Goodwin. (4 yea, Stepney absent). Motion passes.

Mayor allowed Shannon to present a software alert system for water works and town wide communication. Text My Gov costs \$1800 yearly compared to Mayor Command at roughly \$6,000 yearly, with additional capabilities. Shannon proposed this software after extensive research with similar products. She stated that this software will assist our offices to communicate with citizens in emergencies such as the water outage on Hwy 63 for several days.

A motion to contract with Text-My-Gov was made by Councilor Goodwin and seconded by Councilor Mothershed. (4 yea, Stepney absent). Motion passes.

Mayor allowed Kelly Bailey to express her interest in donating the rent, equipment, and utilities for the building at 21 Kowaliga Road in honor of her late husband Desmond Bailey, to use for investigative purposes for the police department/state task force. Her goal was never to step on the Councils toes when she did this.

Councilors Stearns and Mothershed and Pro-Tem Reed expressed deep concern that this was not brought to them beforehand and was rushed. They felt the Council was unable to be given proper time to decide.

Mayor Davenport explained that the Town insurance will not insure the building since the lease is not in the Town's name, therefore the Mayor extends interest in the Council to transfer the lease into the Town's name for one year.

A motion to transfer the lease for 21 Kowaliga Road from Kelly Bailey's name to the Town of Eclectic for a maximum of one year was made by Councilor Goodwin and seconded by Pro-Tem Reed. (4 yea, Stepney absent). Motion passes.

A motion to nominate David Goodwin for the voting delegate for the Alabama League of Municipalities conference in Huntsville, Al. was made by Pro-Tem Reed and seconded by Councilor Stearns (4 yea, Stepney absent). Motion passes.

A motion to dispense reading at length for Resolution 2024-04-001 was made by Pro-Tem Reed and seconded by Councilor Goodwin (4 yea, Stepney absent). Motion passes.

A motion to approve Resolution 2024-04-001 regarding the Back-to-school sales holiday was made by Pro-Tem Reed and seconded by Councilor Stearns (4 yea, Stepney absent). Motion passes.

A motion to amend the budget for \$35,000 to cover an increase in our insurance and Workman's Comp coverage was made by Pro-Tem Reed and seconded by Councilor Goodwin. (4 yeah, Stepney absent). Motion passes.

A motion to make the Christmas theme A White Christmas was made by Pro-Tem Reed and seconded by Councilor Mothershed. (4 yea, Stepney absent). Motion passes.
