3. Financial Reports

- Local Drug Free Communities Fund
 - o 2019 collections: August: \$4,995.38; YTD: \$34,575.77

4. News Around the State and Nation

- Vape watches are now available. The battery is rechargeable and the watch has a touch display screen. The watch comes out of the band for vaping.
- At least three overdose deaths in West Virginia may be linked to a growing trend in Boone County where police believe people are using wasp spray as an alternative form of methamphetamine.
- Fentanyl, a painkiller 100 times more powerful than morphine, is showing up on the streets disguised as other drugs, such as Norco and Xanax.

5. Grantee Report: Decatur Police Department

- Grant funds were utilized to purchase in-car cameras and PBT's.
- The cameras are activated when the emergency lights are on.
- The cameras record both inside and outside of the vehicle.
- The cameras are compatible with all other law enforcement agencies in Adams County.

6. DFAC Business/Discussions

- 2020 Grant Process

• Comprehensive Plan

• The comprehensive community plan has been approved and will be e-mailed to the coalition members.

• Article and Flyer Topics

• Coalition members suggested vaping, concerns regarding sharing prescriptions, letters and testimonials, marijuana potency and payment options for treatment.

Recovery House

- Serenity House has not provided any additional information.
- o Oxford House is evidence-based and a good option for Adams County. Oxford House attended the Drug Symposium. Transportation is now available in the Adams County via Lyft and Uber, which was a requirement of Oxford House.

• Communities Talk: Town Hall Meetings to Prevent Underage Drinking Initiative

- Kelly reached out to the schools to determine if they would be interested in a presentation at their school.
- It was suggested that the presentation could be recorded by one of the schools and shared with the other schools.

• What drug/alcohol issues are you seeing?

- Fentanyl, cocaine, and methamphetamine have been observed in Adams County.
- Kratom may also become a concern as its presence grows in nearby communities.

7. For the Good of the Order/Member Sharing

- A discussion was held about Southeast Elementary School. Members could not think of a way for it to be utilized.
- Baldemar Silva reported that the intensive group treatment program is available. The process is as follows:
 - 1. Schedule an initial assessment with case manager 1-260-728-3906
 - 2. Inform client that we will check insurance for coverage and then schedule with nurse for initial nursing assessment
 - 3. Initial Nursing assessment scheduled with Rick, same day (Monday or Thursday).
 - 4. Initial Paperwork given to be filled out
 - 5. Group treatment starts next day.
