New Jersey Traffic Safety Specialist Program

Program Description

The Traffic Safety Specialist (TSS) Program was first established in Maryland with funding provided by the Maryland Highway Safety Office to support the Maryland Strategic Highway Safety Plan. The TSS designation is a statewide consistent recognition of police officers who attained notable experience, education, training, and proficiency in Highway Safety and Traffic Enforcement methods and procedures. The Maryland program began in 2011 and was opened to police agencies that performed law enforcement duties. Designations were developed by a Criteria Selection Committee, in coordination with the Maryland Police and Correctional Training Commissions. The committee also includes representatives from the Maryland Police Chief's Association, the Maryland Sheriff's Association, and the Maryland Police and Correctional Training Commissions (MPCTC).

The New Jersey Traffic Safety Specialist (TSS) Program intends to promote highway safety among police officers, as well as provide a mechanism for support, acknowledgment, recognition, and prestige among officers who have achieved advanced levels of training proficiency. The New Jersey TSS Program consists of two levels of certification; TSS Level I and TSS Level II.

This certification program strives to motivate and recognize officers who have attained notable levels of proficiency in Traffic Safety. A long-term commitment to the program is required to achieve this recognition of highway safety efforts. This designation is not considered an advanced rank, nor does it qualify for an increase in pay compensation, but has been recognized as a testament to an officer's level of training and expertise in the court of law.

This elective program was piloted through the Ocean County Police Traffic Officers Association in February 2016. Kean University staff, on behalf of the Division of Highway Traffic Safety, will continue to implement the successfully proven Maryland Traffic Safety Specialist Program Model here in New Jersey.

TSS Program Requirements

The TSS Program is open to all Active Law enforcement officers in recognition of extraordinary achievement, while promoting traffic safety on New Jersey roadways. Eligibility involves officers enrolling in the program and submitting documentation materials required for specific TSS Designation Levels that are being pursued.

Applicants must:

- 1. Be an actively-employed, sworn officer in "good standing" by any New Jersey law enforcement agency
- 2. Complete New Jersey police academy officer certification
- 3. Submit the appropriate TSS documentation forms (e.g. course list, certificates of completion, and course syllabus)
- 4. Ensure that TSS Verification forms are signed by an agency supervisor or designate
- 5. Ensure that all TSS documentation forms are submitted by the appropriate quarterly Deadline

Traffic Safety Specialist Level I Requirements

The TSS program requires documentation of experience levels, training, job performance, and skill proficiency as a traffic officer. The first phase enables officers to be recognized for specialized training beyond the academy. *Level I* requirements include three years of independent patrol/traffic experience, speed detection device certification, standard field sobriety certification, and 30 points of earned electives. One elective point is also awarded for each year (up to three points) of documented military experience.

Points are also awarded for documented college experience.

Associate = (1) pts. Bachelors = (2) Masters = (3) pts.

Applicants may also obtain up to seven points for traffic safety awards received from a Law Enforcement Agency, Traffic Safety Organizations, and/or Advocacy Groups such as MADD & SADD, during their employment.

TSS- Level II Requirements

The **TSS-** Level II certification requires the applicant to participate in local traffic studies and/or implementation of traffic safety projects. In Addition, the applicant must have six years of uniform patrol/ traffic safety division experience, hold the **TS-Level I** for one year, and have completed one of the following: Crash Reconstruction, be ACTAR Certified, be a Drug Recognition Expert, or completed the Rutgers' Practical Traffic Engineering for Police Officers course. A written traffic study report must also be submitted by the applicant, along with proof of the thirty (30) Additionally earned Elective Option credits.

Over seventy courses are listed in the nine designated areas of county-based police academies. Additionally, several nationally sponsored programs (i.e. FBI, IPTM, and NIMS) are included in the course list. One half point is awarded to courses that are four hours in duration, while maximum credit of 10 points will be received for 80-hour training programs. The approved Course Lists are attached to both the TSS-1 & TSS-2 applications.



New Jersey TSS Review Committee

The New Jersey Traffic Safety Specialist Program Review Committee is made up of a cross section of representatives of various traffic safety related organizations from across the state. The initial committee was tasked with developing the program, while the current committee is responsible for an ongoing review and updating of the program. The committee meets at a minimum of once a year to review the status of the program.
