- 1. PERMISSION OF PARTICIPATE: I, parent/guardian of the above-named participant hereby acknowledge that my child is in good health and I give my approval for my child to participate in any and all Berkley Timberwolves national, regional, league/conference, association and team/squad activities, including transportation to and from the activities by a licensed driver with proof of insurance.
- 2. INTENT TO INFORM: I acknowledge that I am fully aware of the potential dangers of participation in any sport and I fully understand that participation in football and cheerleading may result in <u>SERIOUS INJURIES</u>, <u>PARALYSIS</u>, <u>PERMANENT DISABILITY AND/OR DEATH</u>. Furthermore, I fully acknowledge and understand that protective equipment does not prevent all participant injuries, and therefore, I do hereby waive, release, absolve, indemnify and agree to hold harmless Berkley Timberwolves and all organizers, sponsors, supervisors, participants and persons transporting the above named participants to and from activities, from any claim arising out of any injury to my/our child whether the result of negligence or for any other cause.
- **3. EMERGENCY MEDICAL AUTHORIZATION:** I hereby grant my permission for any and all emergency medical/dental treatment and/or first aid to be administered to my child/participant, including authorizing any medical treatment facility/hospital to administer emergency treatment, for any illness/injury/accident resulting from participation in any and all Berkley Timberwolves activities.
- **4. EQUIPMENT RESPONSIBILITY:** I agree to assume full responsibility for any and all equipment/uniforms LOANED to the above named participant and I agree to promptly return, upon request, the uniform and other equipment issued to above named participant in as good condition as when received except for normal wear and tear. - **7. ADULT CODE OF CONDUCT: S1:** In order to uphold the goals of Berkley Timberwolves and ensure that all participants have the benefit of a safe and fun learning environment, all parents, guardian and other adults and attendees of Berkley Timberwolves events, including but not limited to practices, competitions and banquets, must behave accordingly in a respectful, courteous and sportsmanlike manner at all times. **S2:** Any adult who is using alcohol, tobacco or non-prescription drugs and/or appears intoxicated at a Berkley Timberwolves event, and/or who is flagrantly rude, attempts to intimidate, verbally abuse, heckles, taunts, ridicules, boos, throws objects and/or uses vulgarity or profane language/gestures with an official, coach, volunteer, staff member, participant or other event attendee, must receive a verbal warning and/or be asked to leave Berkley Timberwolves event.
