	A	<b>I understand and agree that</b> the KarmaKick Yoga Teacher Training Program is intense and highly demanding. <b>I understand and agree that</b> I am not entering this program in ignorance of the degree of professionalism, dedication and effort that will be demanded of me throughout my training. <b>I further understand and agree that</b> I will abide by the supplemental corollary adjunct to this agreement titled <i>Code of Ethics and Student Behavior</i> that I must sign if I am accepted into the program.
	B	<b>I understand and agree that</b> participation in KarmaKick Yoga Teacher Training Program will require a commitment of time, effort and dedication. In this regard, <b>I understand and agree that</b> demands of discipline and character are of the utmost importance in crafting my skills, voice and demeanor as a respected future teacher, or mentor. <b>I further understand and agree that</b> the additional notices and requirements that follow in this agreement are an integral part of my willingness to participate in this program for the purpose of obtaining a high level of training and acquiring a reliable, accountable level of discipline and responsibility.
	C	<b>I understand and agree that</b> once I have paid my tuition in full and fulfill all the requirements of the KarmaKick Yoga Teacher Training Syllabus, including in-class hours, assignments, quizzes, oral exams and passing both the written and in-class final exams, I will receive a letter of completion, which can be submitted to the Yoga Alliance and/or prospective employers as evidence that I have completed a 200-hour Teacher Training program. Paying for the program and completing the hours does not automatically entitle me to a passing grade and/or certification as a yoga instructor.
	D	<b>I understand and agree that</b> KarmaKick Fitness reserves the right to dismiss me from the program if I am found plagiarizing, if my behavior is disruptive, inappropriate, negatively impacting the learning environment, unethical, or I violate the Yoga Alliance ethical guidelines. Under such circumstances, <b>I understand and agree that</b> I will not be refunded any part of my tuition, forfeiting the entire amount.
	E	<b>I understand and agree that</b> KarmaKick Fitness reserves the right at anytime to ask me to leave the training if it appears that my health, or physical condition, stamina, or strength, or my actual physical endurance during posture practice and breathing exercises are not at the level required to fully participate and graduate from the program. Under such circumstances, <b>I understand and agree that</b> I will be given a prorated refund based on the amount of time I have participated in the program.
	F	<b>I understand and agree that</b> if I miss more than 24 hours of lecture and training combined, I will receive a failing grade for the entire program and will be asked to leave the training without a refund of any portion of my tuition. Under such circumstances, <b>I understand and agree that</b> there are only two options available: <ol style="list-style-type: none"> <li>1. If an overlapping program containing the same exact syllabus is offered by KarmaKick Yoga, I will be allowed to make up the missing hours. <b>I further understand and agree</b> that this option is subject to availability and to the limitations of space imposed by class size.</li> <li>2. <b>I further understand and agree</b> that I will be given only one opportunity to retake the program from the start after I pay for a new, full (100%) tuition.</li> </ol>
	G	<b>I understand and agree that</b> I am committing to be at the training hosting venue 15 minutes before the official start time of each session. Promptness includes first arrival for the day as well as arrivals after lunch and short breaks. If I am late to class a third time, I will not receive any credit for the entire day and I will be asked to leave the premises and the building and required to make up the day according to the subjects of availability stated in the makeup policy above. If I am late for a fourth time, I will be asked to leave the program without any refund of my tuition.
	H	<b>I understand and agree that</b> I am making a commitment to attend each of the programs sessions for their entire, respective durations. If I consistently leave more than, or equal to 15 minutes early, on the third time this happens, I will be asked to leave the premises and be required to make up the day according to the availability stated in the makeup policy above. If I leave early a fourth time, I will be dismissed from the program without any refund of my tuition.

	I	<b>I understand and agree that</b> if I cancel 15 days, or more before the start of the training, I will receive a full refund. If I cancel within 14 days before the start of the program, I will forfeit \$250 dollars of my deposit and my remaining balance will be refunded. The \$250 forfeit is non-refundable, non-negotiable and non-transferable. <b>Once the program is underway as of one second past the official start time (Start Time + 1 second) of Day 1, my tuition is non-refundable.</b>
	J	<b>I understand and agree that</b> if I request to transfer from one KarmaKick Yoga Teacher Training Program to another within 1-5 days of any weekday program and 1-5 days of any weekend program, I will need to restart the training program from the beginning and pay a transfer fee of \$500.
	K	<b>I understand and agree that</b> if I am dismissed or leave the program without completing the syllabus and certification requirements, I am not entitled to any refund of my tuition or to any graduation merits or to any certificate of completion or to any diploma or to any professional association with KarmaKick Fitness, KarmaKick Yoga, or any modality bearing the KarmaKick name. <b>I further understand and agree that</b> misrepresenting my credentials and falsifying documentation as stated in the previous sentence, I may be subject to prosecution for illegal misrepresentation and subject to legal proceedings thereof.
