## ***Meeting Minutes***

June 21, 2018

### **I. Call to order**

Chuck Howell called to order the regular meeting of the Gate City Sport Shooting Association at 7:00 pm on June 21, 2018 at the Oregon Trail Shooting Range Larry Allenbaugh Clubhouse.

### **II. Attendance**

### **III. Approval of minutes from last meeting**

Approval of the May meeting minutes was motioned by Steve McClung and seconded by Richard Lopez. A vote to approve the May meeting minutes was unanimously in favor.

### **IV. GCSSA finance update**

Denis Freudenthal discussed the GCSSA financial transactions that have taken place since the May meeting.

### **V. Membership update**

Earmal reported that 200 new packets have been distributed to stores. CAL Ranch and Sportsman are behind on payments due to slow processing within their accounts payable departments.

### **VI. Shooting discipline reports**

3-Gun had a good turnout of about 22 participants. Rangers and Vaqueros both had shoots and good turnouts.

### **VII. Old Business (open issues)**

#### **a) Ongoing Range Projects**

- The Hot/Cold Range system will be in place by July 7<sup>th</sup>.
- Need to purchase more carpet and glue, set a date for the work party.
- Burning of wood will wait until fall or winter.
- Payment for materials for the shade in Gulleyville was made. Delivery of materials to take place in early July.
- Wall Extension for Gulleyville with a work party scheduled for July 8<sup>th</sup>.
- Wood chips, Kelly to spread and will level ground for the wall extension.
- Pothole filling – Chuck working to get this done.

- Eagle Scout project has materials purchased and work as begun.
- b) Revision of GCSSA bylaws – Tabled for the full board to review prior to submitting to the membership for a vote
- c) Five-Year Plan – Richard Lopez will coordinate the collection of ideas. Email to members to be sent out to solicit ideas.
- d) BLM land purchase – No new news to report.

### **VIII. New business**

- a) Pistols for Pets – Scheduled for July 7 with donations from Sportsman’s Warehouse, CAL Ranch and Pet Smart. The event will start at noon and finish about 2 pm. Help needed to set up steel targets and manage the range.
- b) Overview of work done by ICCU employees on a range project, steps from the main firing line parking area down to the gate going towards the box car.
- c) Barbecue/Picnic – Unsure if there is enough interest for a turnout to hold this event.
- d) Vests for Range Safety Officers. John Rook will look at cost to purchase safety vests so that RSOs can wear them while performing their duties at the range. Approval was given by the board to purchase the vests once a cost is determined.
- e) Request from the Portneuf Muzzle Loaders to use the range and club house on August 14 at 6 pm. Approval given.
- f) Metal poles installed in the 25 yard bay to replace the landscaping timbers that are being shot up. Denis is to contact Pacific Metals for additional pole material.
- g) Initial discussion of the range hosting a hunter sight in day or days in early September. Discussion also included volunteer support to manage the shooter and fee to charge shooters for the event.
