DRIVEWAY CULVERT MARKERS

The Summer Village taxable assessment for 2022 increased \$255,840 as follows:

New development: \$ 226,100 Increase in market value: 29,740

\$<u>255,840</u>

Property Assessment and Tax Notices will be mailed on June 1, 2023. The deadline for tax payments is July 12, 2023, after which a 15% penalty is charged on unpaid taxes.

2022 Audited Financial Statements

The Summer Village Audited financial statements for 2022 have been prepared by JMD Group, and are available from Administration and on the Village website. Click on the "Documents" page.

The Summer Village has a contract with the County of St. Paul for snow removal and grass cutting along the sides of the Village roads/streets. The County has implemented a new policy of **marking culverts**, to avoid damage to both the culverts and the grass cutting equipment.

If you have a culvert under your driveway or along your street, please notify the Village office, so markers can be placed on all culverts in the Village.

WASTE DISPOSAL/GARBAGE BINS

The garbage bins in the Village are for **BAGGED HOUSEHOLD GARBAGE ONLY**.

Any large items or construction materials can be taken to the land fill sites at Mallaig or Vincent Lake, RR 95. The bins are emptied every Wednesday.

MISCELLANEOUS REMINDERS

<u>DOGS ETIQUETTE:</u> Dogs in the Village MUST be kept on a leash or tied-up in your yard. Also, please do not let your dog do his business in your neighbors yard. The Village does not have a dog bylaw, therefore dog problems should be resolved between neighbors.

One big reason for keeping your dog on a leash, is there are bears, skunks & porcupines in the area.

FIRE BANS: Check www.albertafirebans.ca before coming to your cottage or phone the Village office. Circumstances can change very quickly. We follow the County's lead on declaring fire bans. There is a provincial ban on off-road vehicles in forested areas. So please be very cautious when quadding on the trails around the Village.

BOTTLE RECYCLING: Bottle Recycling bins are located at the waste bin site across from Martin Rec Center. The bottle money is used for Village social or recreational activities.

Thinking of Developing?

If you are thinking of developing on your property in the Summer Village, now is the time to start the application process. No development shall be undertaken in the Summer Village unless an application has been approved and a Development Permit has been issued

- Make sure you know exactly where your property line is.
- Apply for a development permit from the Summer Village, at least 3 weeks before you plan to proceed.
- Application forms are available on the Village website or from the administrator. A site plan showing dimensions and location of all buildings should be attached to the application.
- ◆ After your development permit is approved, make sure you have all the required permits, such as: building permit, electrical, plumbing, gas & sewer. These can be obtained from Superior Safety Codes: (1-886-999-4777)
