**NOW, THEREFORE**, the Association's Collection Policy is hereby amended to add new Paragraph 17 to address further partial payments by Owners as enumerated in the text attached hereto as Exhibit A and made a part hereof by this reference.

**BE IT FURTHER RESOLVED,** that the Board of Directors directs Association's Management staff to disseminate a copy of this Resolution to all members (via General Notice, if applicable) within 15 days of adoption.
