2. Approval of Minutes from the January 9, 2013 North MB BID Meeting **Vote approved/unanimous*

3. City of Manhattan Beach Police Department Representative to be present for overall North MB BID general safety discussion and answer questions.

- Lt. Andy Harrod MB PD discussed recent activity in North MB; vehicle break-ins and residential burglaries (lock it or lose it program). Recommended making sure cars and homes are securely locked. Contact the City MB PD if you see anything suspicious.
- Discussed a recent MB Police "walk about" visiting the businesses in NMB. Police b. introduced themselves to the NMB that were open early in the morning.

4. Discuss North Manhattan Beach BID annual Summer event. Chose event theme, name and date. Discuss assignments and cost.

- **a.** The BID members voted unanimously to hold one "Stroll" in 2013. The Holiday Stroll was chosen as the event scheduled for December 2013. There will not be a "Summer Stroll" in 2013.
- **b.** BID discussed other types of events in addition to the above stroll.
- 5. Review directory map provided by the City's GIS Analyst with updated businesses provided by the City's Business Licensing Office. Discuss and take action to continue with the use of City GIS or outsource.
 - a. Steve Charelian presented the updated directory map and will deliver final at next meeting.
 - **b.** Make the numbers in order from top to bottom with different colors. Take off addresses and use only phone numbers of businesses.
- 6. Public Hearing will be held at the February 5, 2013 City Council Meeting to Discuss and Adopt the Annual Assessment, Ratify the new NMB BID Advisory Board and Review Proposed 2013 Enhancement Project and Activity Plan.

- 7. Status Update on 2013 Project and Activity Plan Project: Lighting strategies for solar powered lamps.
 - **a.** Many of the light posts (SCE) in the NMB BID need to be repaired.
 - **b.** Solar ambient light posts were discussed. Some businesses do not want the lights and feel the trees that have been planted and adding solar lights will be too crowded (item deferred until future date TBD)
 - **c.** Request a traffic study to be done to review lighted crosswalk for public safety.
