Will be getting costs later. life 6 to 10 year span.
- 2. Fire department. Jesse. Trained. Future training to be scheduled, water barrel and pump hose operations. Application for David Ferebee FF/EMT. Trustees reviewed aplication. Motion to hire David Ferebee with passing of pre-employment screens.
