TOWER REPORT

Chairman Woods reported for the month of May 2021 the traffic count was 7,860 operations which is up 521 (7%) operations from April 2021 and up 2,795 (55%) operations versus May 2020.

AIRPORT MANAGER'S REPORT

Airport Manager Chris Lynch reported on the following topics.

Upcoming events

- June 19th Annual NH Aviation Museum Fly-In & BBQ
- June 23rd June 27th Commemorative Air Force at ASH. The CAF B29 Squadron aircraft attending this event will be:

B-29 Superfortress FIFI, Wasp T-6 Texan, P-51 Gunfighter and PT-13 Stearman.

CAF will arrive Monday June 21, Depart Monday June 28. Gates open 9am to 5pm, each day June 23 to June 27. B-29 Squadron will run the gate. Gate fees are \$20/adult and \$10/child over age 10. All aircraft rides will be booked through the B-29 Ride Desk and/or online https://www.airpowersquadron.org/Nashua-NewHampshire. Local flight schools will be advertising at this event.

Other items of interest

- June 1st & 2nd Site visit at ASH with Weston Solutions. They collected water samples from existing well sources located at 3, 5, 117, 125 Perimeter Road and monitoring wells located inside the airport fence near the approach lights adjacent to Deerwood Drive.
- June 1st- I presented the NAA budget to the City of Nashua Budget Review Committee via a Zoom meeting.
- June 2nd NAA and Midwest ATC conducted our annual RSAT (Runway Safety Action Team)
 meeting via Zoom. There were no incursions reported for the past year and only one excursion.
- June 7th- Phase III of the Pavement Maintenance Project has begun.
- June 7th- NAA staff met with Infinity Aviation and NJA representatives to discuss the pavement maintenance projects and our upcoming events, NH Aviation Museum BBQ and the Commemorative Air Force event. Primary topics of discussion were safety, line service and transient aircraft handling/parking.
- There are two T-Hangars for sale at KASH. One is located at 13 Perimeter Rd. and one is available 127 Perimeter Road. Also, community hangar rental is available from Nashua Jet Aviation and Infinity Aviation.

AIRPORT ENGINEER'S REPORT

Nik Ippolito appeared on behalf of the airport's engineering consultant, Gale Associates, Inc.

CONSTRUCT ONLY - Pavement Maintenance Phase II (NHDOT No. SBG 12-21-2020)

This Project is to reconstruct taxilanes between hangars located on the north-west side of the Airfield (Runway 14 end.)

Project Status:

- On Monday June 8, 2021 the Contractor began work in Phase III of the Project.
- The Per the Contractor's schedule, construction in the Phase III Work Area must be completed by Saturday, June 26, 2021. Gale has processed the Contractor's April pay request and incorporated it into the next Reimbursement Request. This Reimbursement Request has been forwarded to NHDOT/BA for processing; the funds should be deposited in the Airport's account sometime this month.

- Gale has processed the Contractor's May pay request and submitted that information to the Contractor for concurrence. Once they approve and sign their pay request, it will be worked into the next Reimbursement Request.
- Gale has processed the Contractor's May pay request and submitted that information to the Contractor for concurrence. Once they approve and sign their pay request, it will be worked into the next Reimbursement Request.
- Change Order No. 1 for this Project has been sent to NHDOT/BA for approval. This Change Order was requested to cover out-of-scope work that was performed by the contractor, including:
 - 1) Removal and replacement of sagging drainage pipes in the Phase I work area
 - 2) Removal and replacement of an existing stormwater structure in Phase I.

REHABILITATE TAXIWAY 'A' AND ASSOCIATED TAXIWAYS

This Project is for the design and construction phases necessary to rehabilitate Taxiway 'A', install new taxiway edge lighting (MITLs), and to address the grading issues at the intersection of Taxiway 'A' and Taxiway 'D'.

Project Status:

- The grant application has been submitted to NHDOT/BA for funding through the Airport Improvement Program. The anticipated grant issuance is sometime before the 30th of September 2021.
- The Low Bidder on the Project was Sargent Corp. of Stillwater, ME. The Contractor's bid price was \$2,030,172.50.
- Contracts between Sargent Corp. and the NAA have been prepared by Gale. With concurrence from the NAA, Gale will circulate these Contracts and begin preparing for the pre-construction conference.
- Gale is preparing the Airport's Industrial SWPPP for submission to EPA for coverage under the 2021 MSGP. Once the draft SWPPP is assembled, a digital copy will need to be posted on the Airport's website for EPA review. Gale anticipates having a draft completed for Authority consideration before the end of June.
