Mr. Richard Shape passed away and Jerry Shape will be taking over the account. The remaining balance of \$42.42 was removed from Richard's account and placed on Jerry's account.

#### **OLD BUSINESS:**

#### A. Sump Pit Repairs

These repairs are currently on hold due to the iron filter repairs that need immediate attention.

# B. <u>Miscellaneous Repairs</u>

The leak on third street, as previous reported, has been repaired. The Burkhart fire hydrant has not yet been scheduled for repair. The fire hydrant on Fantasy Island that was thought to be an issue, is not leaking and no repairs are needed.

#### **NEW BUSINESS:**

# A. 2001 Blue Pickup Truck

The pickup truck has had all extra installed equipment removed. Since the purchase of the Yukon, street & water workers do not have a need for the truck. The board has no objections with selling the truck on GovDeals.

### B. Ohio EPA – Lead Notification and Action Level Exceedance Letter

The board was provided a copy of the letter from the Ohio EPA in regards to a lead compliance program. Mr. Albert is aware of the requirements and will act on the issue accordingly.

#### C. Office Renovations

Mr. Weidner informed the board that Ms. Karen Beasley, Architect quoted a significantly lower cost to draw up the plans required for the office renovations. Once the drawings are completed, he will provide a copy to the board for approval.

# D. Iron Filter Repairs

Mr. Albert reported that filtration material in tank #2 has been removed. It appears that a cap in the base piping had come off allowing gravel & filtration material to backup into the lines. It is estimated to cost \$40,000-\$45,000 to rebed the filters. A notice has been issued to let residents know, though it is not harmful, they may notice some discoloration in their water.

Ms. Ann Elleman moved to adjourn the meeting. Mr. Greg Iiams seconded the motion.
