### LYNN MEHTA

“The fluidity and flexibility of oil paint is well-suited to my creative process. Color, light, composition, and paint handling are key elements in my paintings and tools for my expression. When I paint I connect with changing light, the color of the landscape, and movement. I focus on abstract shapes and forms creating a whole. I was influenced by the art of my mom who painted the California landscape and encouraged my interest in art by setting up my toddler easel outdoors, enrolling me in art classes, giving me personal instruction, and purchasing art supplies for me. I developed a love for books early and spent hours pouring over the “Art for Children” books by Ernest Lloyd Raboff, and especially Pablo Picasso and Paul Klee.”

Lynn has achieved Signature Status Membership in the American Society of Marine Artists and the Mid-Atlantic Plein Air Painters Association and juried into the Oil Painters of America, the Salmagundi Club and the Washington Society of Landscape Painters. She is an elected Fellow in the American Artists Professional League, New York, NY. Other memberships include the American Impressionist Society, California Art Club, the Art League of Alexandria, and the Maryland Federation of Art.

Lynn lives in Alexandria, Virginia. She grew up along the Pacific Ocean, in La Jolla, California and teaches at CFAS in Stevensville.

## The Human Form

### An Open Judged Show of Figurative Works

January 29 - March 1, 2020

This show is non-juried. Each artist may enter up to three works. Work must be original, completed within the last two years, must not have been previously shown at KIFA's gallery shows, and must not infringe upon any copyright. No reproductions will be accepted.

Sculptures must include their own base or fit on a KIFA pedestal. Sculpture artists must be prepared to assist in placing their work in the gallery. Maximum size including base: 6' high x 3' wide and deep.

2-D work must be dry, suitably framed, wired, and ready to hang. If not, it is at the discretion of the gallery director whether to hang the piece. No saw tooth hangers. Maximum size frame: 40" x 40".

Minimum size frame: 8"x10". All works on paper must be under glass with no exposed glass edges.

KIFA reserves the right to reject works deemed unsuitable. All entered works must remain on display through the end of the show.

KIFA is not liable for loss of or damage to artwork. Reasonable care will be taken to ensure the safety of your artwork.

Non-refundable fee must be included with entry. KIFA requires a 30% commission on all sales.

#### Accepted Media

Oil/Acrylic, Water Media (watercolor, gouache), other 2D media (pastel, pencil, collage, etc.), hand-pulled prints, photography and sculpture.

**KIFA reserves the right to re-categorize entries.**

#### Awards (Cash and Ribbons)

Entries will be judged on overall design concept, creativity, and craftsmanship.
