

**Application for Entry - Havasu 600 Air Race**

Step 1: If you are racing or even thinking about racing, please make your hotel reservations as soon as possible. The hotel in Tucson sells out, and regular price room are over \$250 a night. The Start hotel in Sedona is the only one within walking distance of the airport. All hotels have a 24 or 48 hour cancellation policy, so it won't hurt to make those reservation now! Step 2: This application must be filled out completely and submitted with the entry fee. Entry fee for crew is \$270, includes pilot and right seat passenger/co-pilot. Each additional back seat passenger is \$70. Entry fee includes banquet for pilot, co-pilot and back seat passengers. If you have guests that would like to join us for the Awards Banquet on Saturday evening, additional Banquet tickets may be purchased when you register for \$40.00 per person. **Deadline for entry is Oct 7, 2019**

3. I hereby certify that the aircraft which I shall use in the Havasu 600 Air Race meets the specifications as stated in the Rules and Regulations, governing the current Havasu 600 Air Race.

I hereby agree to submit my aircraft for extensive inspection at the Start and Terminus of the race as provided in the Rules and Regulations, and to allow the inspection committee to check it in flight, straight and level, throttle wide open. Federal Aviation Administration Certificated Mechanics, authorized by the officials of the Havasu 600 Air Race may conduct or perform any examination to establish that the aircraft conforms to the manufacturer's stock model rating and to the standards by which it is certificated per the CFR's.. I understand that my aircraft is not to be released from impound until after the terminus inspection has been completed and race results are announced.
