## Directions to Host Hotel

FROM Lambert International Airport: Start out going northwest on Lambert International Blvd.

Make a U-turn onto Lambert International Blvd.

Take the ramp toward I-70 W/Terminal 1/Rental Car Return.

Merge onto I-70 W/Mark Twain Exp. Merge onto I-270 S via EXIT 232B-A toward Memphis. Merge onto I-44 W/US-50 W via EXIT 5B toward Tulsa. Turn right onto Six Flags Rd. If you reach I-44 W you've gone about 0.3 miles too far. Six Flags Road become Allenton Road.

FROM HOST HOTEL TO THE Purina Farms: Start out going south on Allenton Rd toward Six Flags Rd. Allenton Rd becomes Six Flags Rd. Merge onto I-44 W/US-50 W. If you reach US Highway 66 you've gone about 0.1 miles too far. Take the MO-100 E exit, EXIT 253, toward Gray Summit/I-44 Bus Loop. Keep right to take the ramp toward Gray Summit/Purina Farms. Turn right onto Highway 100/MO-100. Highway MM is 0.2 miles past Pettus Ave. If you reach Hogan Rd you've gone about 0.1 miles too far. Turn left onto Checkerboard Dr (Gate access required). Checkerboard Dr is just past Danforth Dr. If you reach Chow Dr you've gone about 0.1 miles too far. Turn slight left to stay on Checkerboard Dr. If you are on 4 Square Dr and reach Checkerboard Loop you've gone a little too far. Turn left onto Checkerboard Loop. 300 CHECKERBOARD LOOP is on the right. If you reach Technology Dr you've gone about 0.1 miles too far.

## ATTENTION EXHIBITORS

- Show site will be available for exhibitors Monday, September 29, 2014. Dogs should be removed from the show site as soon as possible following judging on Friday, October 3, 2014.
- Crating and grooming will be allowed in designated areas only. Cleanup of the grooming areas will be the owner's responsibility and will be policed daily. Dogs may **NOT** be left overnight in the grooming areas.
- Neither the show-giving Club nor the host site will be responsible for the safety or wellbeing of dogs or other property left at the site.
- Exhibitors will be responsible for maintaining clean conditions around their grooming area. Exhibitors should bring their own cleaning supplies.
- After loading and unloading, vehicles must be moved to the parking area. No parking is allowed immediately adjoining the loading and unloading area.
- Trash receptacles and clean-up stations have been placed throughout the grounds to make it easy for you to clean up after yourselves and your dogs.
