FAIR GROVE SENIOR CENTER SANITARY SEWER CONNECTION ISSUE.

Terry Dean representing the Huff Brothers discussed the different options of running sewer line for the Senior Center. By running sewer line east it will help with future growth in the area.

Leon Beaty, 189 N. Arrowhead, Charmin of the Senior Center stated the Senior Center will pay the original cost of the existing west plan of \$9875.

The Huff Brothers will pay \$12,125 to have the sewer line go to the east.

Short reported it looks good to him. Miller stated the east plan is best for the city. Consensus of the Board to move forward with the east option for sewer extension.
