RESOLVED, that the Town Board hereby orders that vehicles described in the law having a weight of eight tons or more are prohibited from traveling on Beaver Dams – Moreland Road and Cronk Road, local deliveries excluded; and

RESOLVED, that the Town of Dix Highway Superintendent shall post notice of such order.

All services terminated to a residence will have the past due amount re-levyed to their property tax in the coming year. This will take place every November before property tax preparation is underway.
