Financial Overview

• The Authority ended the year with a significant improvement of \$179,105 over the previous year. Including the soft costs of depreciation and unbudgeted pension expense the year still ended in the negative by \$124,589. However, the soft costs are deducted when the Auditor determines the need for a "Growing Concern". Before soft costs, the Authority ended the year with net revenue of \$50,061. There should be no "Growing Concern" comment in the 2018 audit.

- Healthcare Renewal Increase: Open enrollment and premium increases were conducted for an effective date of January 1 vs. the usual July 1 date. The Township wanted to move Health Insurance policies to a calendar year enrollment. The Authorities health insurance had a 20% increase in cost.
- 2018 Year End Audit: The year end audit for 2018 has been scheduled for the 3rd and 4th weeks in March.
