

Wheatland Crossing Apartment Project Sent Back by City Development Commission for Community

Input

News Commentary

What began as a proposed rezoning of a 3-acre parcel to Apartment Residential 1, and a 60-unit apartment building at 102 N. Wheatland Avenue,



migrated to a next-door 3-acre tract to the north at 158 N. Wheatland Avenue, in front of the current Senior Housing Complex as "Inter-generational Housing with fruit tree orchards. Although this was for a lesser density rezoning request to ARLD (but still greater than the 2010 Hilltop Plan Amendment called for on that site), it still had 60 units. The project finally transmigrated into becoming a "Gardening Community" 60-unit apartment complex in conjunction with the Mid-Ohio Food Bank Garden which would remain on the original site at 102 S. Wheatland, with the fruit orchards from the second plan retained and the urban farm added. Throughout the process the building remained a large scale 3-story building set directly across the street from much smaller scale single family homes. All of this was without any proposal to widen North Wheatland Avenue and the developer asking that the parking requirements be reduced from 90 to 69 parking spaces for the 60-unit building. During the process there was no public input, the HWCA was not even contacted, and it was to all be rushed through during a very busy holiday season, with what appeared to be the full blessing of the Area Commission leadership and the Hilltop Business Association's designate as the "leader" of the NCR District (Highland West) along Broad Street who currently serves as an "appointed" commissioner on our Area Commission through June 2018.

The Westgate Neighbors Association came to the aid of The Highland West Civic Association, and **together we fought to bring this to a halt** because it did not fit into any of the development plans that the City had for the Hilltop, particularly concerning the open acreage behind the old firehouse, and to have real community input before any plans be put forward for approval and execution.

Repeatedly this new apartment building was made to look as if it were simply "Senior Housing", but it was not—it was for the general population. Although it was to be funded with the use of Low Income Housing Tax Credits (LIHTC), it was difficult to pin down any ratio from the developer as to how much of it was to be developed under the LIHTC program. On December 5th, we learned that amount was 75% was to be developed as low income housing and 25% was to be made available for regular work force housing with rents ranging from about \$650 (for a one bedroom) to almost \$1,300 per month. The community fully supports affordable housing, but at the same ratio we see in the new developments in other struggling areas of the City, 75% work force rentals and 25% set aside as affordable housing units. If the West Broad Street corridor is to ever come back and be viable, we MUST have mixed income housing development in its surrounding residential areas, which we will continue to advocate for with the GHAC and the HBA, as long as the business association is in charge of the Highland West NCR Strip on Broad. Our area commission had a tie vote on the zoning recommendation which constituted a "no" and voted "no" on the variances requested as to the parking and the screening requirements. The HWCA circulated petitions, door to door, throughout the area on the north side of Broad Street which showed that 93% of residents opposed having an apartment complex put on N. Wheatland; this percentage remained consistent with each street covered.

Representatives from the Westgate Neighbors Association and the Highland West Civic Association, together with many neighbors from Westgate and Highland West attended the City of Columbus Development Commission Hearing on Thursday evening, December 14th. The Development Commission agreed with us in that the proposed development did not fit into our area development plans, describing it as "heavy handed" and a "monolithic wall that would overpower a residential street." Notably, in their opinion, the plan did not seem fully developed and they felt the developer could do better. They did agree that there were some good elements in the plan such as a "community room" and a partnership with the Mid Ohio Food Bank farm, but the developer needed to come back to the community and together put together a plan that not only fits into the area, but also follows the neighborhoods development plans approved by the City.

The two communities of Westgate and Highland West, with their civic associations, joining together and acting as one and with one voice, is what made the difference. We see value in all our neighborhoods and there is no such thing as "good enough" or "we won't be able to do any better, so we have to accept whatever we can get". That is old thinking. Uniting as a community and joining forces with other neighborhoods are the keys to making Highland West and all Hilltop neighborhoods the very best they can be. The potential is there, so during the coming year let's go for it! Make it a New Year's resolution to become actively involved in our civic association. Your involvement DOES matter.

The developer has reached out to us to us since the December 14th meeting and we will keep everyone informed as this phase begins. A special thanks as well goes to our neighbors to the west in Westgate because without their assistance and involvement, there may have been a very difficult outcome. Now, on to the next phase— Everyone's help will be needed!
