Program: A Comprehensive Rockfall Mitigation Project on the Scenic California Coast

Two adjacent unstable slopes along the Scenic By-Way (California Highway One) within the Central Coast of California were mitigated using a rock shed and a long–span bridge. The project development spanned over 20 years and faced numerous challenges requiring the development and implementation of a coast highway management plan, which included interests of all stakeholders and ultimately led to successful completion of this complex project. The rock shed, the first of its kind in North America, was designed to absorb impacts in excess of 1000 kJ and to allow rocks to pass over the road. The bridge design allows the rock slide and associated rockfalls to translate underneath the roadway requiring a 500-foot span to prevent lateral loading and rockfall impacts on the intermediate piers.
