"Diversity in Culture" will be a special award given to a designated piece that best represents the theme, in any medium above. Artists may enter up to three works and are encouraged to include a narrative with their work.

Sculptures must include their own base or fit on a KIFA pedestal. Sculpture artists must be prepared to assist in placing their work in the gallery. Maximum size including base is: 6' high x 3' wide and deep. **2-D works must be dry, suitably framed, wired and ready to hang.** No sawtooth hangers. (Artwork not wired properly will not be accepted.) Maximum sized framed 40" x 40". All works on paper under glass, should have no exposed edges. We will accept sealed water media without glass.

KIFA does not discriminate against anyone and encourages diversity in all works that KIFA's Gallery Committee deems is suitable for the public to view.

All entered works must remain on display through the end of the show. Reasonable care will be taken to ensure the safety of your artwork. KIFA is not liable for loss or damage to artwork.
