#### THE VALUE OF MENTORING

We have all benefited from mentors in our lives, both our personal and professional lives. Our mentors are those who have helped to guide our development as we have grown. They often come into our lives, either by chance or by opportunity, undeclared as mentors, and the mentoring relationship grows over time through the development of mutual respect. In all cases, they have been instrumental in our success. the firm in 2014 after 30 years. Bob graduated with B.S. and M.S. degrees in Civil Engineering from Penn State University. Upon graduation, he served as an officer in the U.S. Army Corps of Engineers, and then worked with two international engineering companies in Omaha, NE, Berkeley, CA and Denver. In 1984

FHU was formed to provide transportation consulting services to both the public and the private sectors. Under Bob's leadership, FHU has grown into a highly respected regional firm with 130 professionals in four offices in the Rocky Mountain and Midwest regions. He is very proud of the fact that FHU has been named "Small Business of the Year" by the South Metro Chamber of Commerce and has also been recognized as the "Employer of the Year" by the Women's Transportation Seminar.

Bob is a member of the Institute of Transportation Engineers, and has served as the President and National Director of the American Council of Engineering Companies of Colorado (ACEC). In 2012 he was honored with the Orley O. Phillips Award, ACEC's highest honor for outstanding contributions to the consulting engineering profession.

Bob also remains active at his alma mater, currently serving on the Industrial and Professional Advisory Council to the College of Engineering. In 2014 Penn State honored Bob by recognizing him as an Outstanding Engineering Alumnus.


