

**RESOLUTION NO. 196-2016**

**RESOLUTION OF THE BOARD OF DIRECTORS OF  
APPLE VALLEY HEIGHTS COUNTY WATER DISTRICT  
WATER RATES AND CHARGES FOR WATER SERVICE  
AND OTHER RELATED FEES**

On motion of Director Braun, duly seconded by Director Woody, and passed, the Board of Directors of Apple Valley Heights County Water District does hereby find, determine and order as follows:

- a) That under the provision of the Water Code of the State of California, pertinent sections of which are hereinafter cited, a County Water District has the duty (Section 31007) and the authority (Section 31025) to fix water rates and to establish rules and regulations for the sale, distribution, and use of water (Section 31024).

The Board finds and orders that:

- a) The following water rate and other related fees and charges are necessary to meet the operating expenses for the district.
- b) Notice of hearing has been published in the Valley Wide Newspapers a newspaper of general circulation within the district on July 15, 2016 and July 22, 2016.
- c) A public hearing has been duly noticed and held on Wednesday, August 10, 2016, at 6:00 p.m. and any and all testimony has been heard and the Board of Directors has considered all testimony.

Now therefore the Board of Directors resolves as follows that the water rates and other related fees and charges shall be increased in these amounts:
