

Truck or Air Freight Orders: Are paid prior to shipment unless freight collect has been arranged.

Proper Procedure for Damaged Goods or Shipment Shortages: Upon receiving your order from Wings of Freedom, Buyer must examine contents for damages or shortages. Damages due to shipping must be reported within 2 days from receipt of order. Shortages must be reported within 7 business days of receipt of order. The following procedures must be followed if any damage and or shortage have occurred:

Procedure for Reporting Damages on Truck Shipments:

1. If your shipment was sent via truck you must have the truck driver or yourself note there was damage to the cartons on the freight bill at the time you accept delivery. Failure to do so will result in loss of right to file a claim to receive compensation for losses that may have occurred. All shipments are insured so you the Buyer or Wings of Freedom will not be financially liable for damages that may occur during shipment. 2. Contact Wings of Freedom for additional instructions on how to file your claim or receive approval to return goods. Goods returned to Wings of Freedom without prior approval will not be accepted.

UPS or Fed-Ex Shipments:

1. If your order was shipped UPS and damage has occurred, contact Wings of Freedom immediately to report damage. DO NOT return merchandise. KEEP ORIGINAL CARTON! Wings of Freedom will then contact UPS and an inspector from UPS will come out to your location and examine your claim. 2. Wings of Freedom will authorize a return of merchandise once inspection has been completed. Failure to follow this procedure will result in loss of right to file a claim to receive compensation for any losses.

Procedure for Reporting Shortages:

If any parts are missing from your order, contact Wings of Freedom within 7 business days of receipt of order and report items that are missing.

PURCHASE ORDER

When this purchase order is accepted by Wings of Freedom, LLC., (hereinafter “Wings of Freedom”), it will become a binding contract of purchase and sale of the products shown on page one (1) hereof upon the terms and provisions herein specified:

I. Each kit order must have a minimum deposit of no less than 60% with your order unless you have been pre-approved for a Payment Plan. Payments can be made by wiring funds, personal check, bank check, or money order. Orders which include options or accessories such as engine, instruments, parachutes, and special items must include payment in full for those items with the order. Any custom work must be paid in full with order. Contact Wings of Freedom for a written quote and dollar amount that should be sent with your order.

II. Any balance due on an order must be paid prior to shipment or customer pick up. Wings of Freedom will notify Buyer when final balance is due. Final payment can be wired funds or be in the form of a bank check or money order. Personal or company checks will be cleared with the bank before final shipment goes out.

III. All prices and specifications are subject to change without prior given notice. Wings of Freedom will advise Buyer of price increases or changes prior to signing contract. Once contract is signed by both parties prices are locked in except for final shipping cost do to changing fuel cost.

IV. There is a restock/cancellation fee on all orders returned or canceled. Such fee shall be based upon current standard percentages at the time of cancellation or return, and will not be less than 20% of the total sale. Wings of Freedom reserves the right to refuse cancellation of any order. Custom orders can not be cancelled under any circumstances and no refund will be issued.

V. As far in advance as is practicable, Wings of Freedom will notify Buyer of the date when the products ordered will be ready for delivery, referred to hereinafter as the "delivery date." Buyer agrees to accept delivery on said date or within a reasonable time thereafter, not to exceed ten (10) days.

VI. Wings of Freedom shall not be liable to the Buyer in any way for failure or delay in making delivery on the delivery date specified by Wings of Freedom where such delay arises from failure to secure sufficient skilled labor, materials, parts, or any other essential elements, necessary to the completion of said materials package, or for delay caused by strikes, fires or causes beyond its control occurring in or in connection with manufacture of said products or in the manufacture and delivery of any purchased parts thereof, or where delivery is prohibited or prevented by or pursuant to any law or regulation whether or not arising out of Wings of Freedom's violation there of and non compliance there with. Buyer hereby releases and discharges Wings of Freedom from any and all liability for damage or loss arising from failure of Wings of Freedom to make delivery for any of the causes herein specified.
