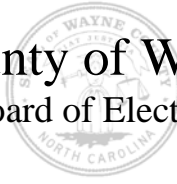

RESOLUTION TO BEGIN COUNTING ABSENTEE BALLOTS ON NOVEMBER 3, 2020 AT 2:00 P.M. AND TO ADD ABSENTEE BOARD MEETING ON NOVEMBER 12, 2020 AT 2:00 P.M.

WHEREAS, the Wayne County Board of Elections has the authority upon a resolution adopted by the county board of elections to begin counting absentee ballots at 2:00 p.m. on Election Day. N.C.G.S. §163-234(2);

THEREFORE BE IT RESOLVED that the Wayne County Board of Elections hereby orders absentee ballots for the 2020 General Election to be counted at 2:00 p.m. Results will not be released until 7:30 p.m. on that day.

WHEREAS, the Wayne County Board of Elections has the authority upon a resolution adopted by the county board of elections to provide for an additional meeting following the day of the election and prior to the day of canvass to count absentee ballots received pursuant to N.C.G.S. § 163-234(11);

THEREFORE BE IT RESOLVED that the Wayne County Board of Elections hereby orders an Absentee Board Meeting be held on Thursday, November 12, 2020 at 2:00 p.m.
