TOWNWIDE CLEAN-UP:

TOWNSHIP PROPERTY OWNERS:

Blairstown Township will be providing free clean-up to property owners on the following dates:

Monday, September 23

through

Saturday, September 28

A voucher system will be used. A voucher entitles residents to bring:

- 1) **One vehicle, car , van or pick-up (1 voucher required)**
Cars and SUVs with trailers require only 1 voucher
OR
- 2) **Pick-up trucks/vans with trailer (2 vouchers required)**

Deliveries are to be made to the Warren County Landfill in Oxford, N.J., Mon—Fri from 7:00 am to 2:30 pm and Saturday from 7:00 am to 11:00 am. **During the dates above only.**

EACH VOUCHER MUST CONTAIN THE RAISED SEAL OF THE MUNICIPALITY. PHOTO COPIES OF THE VOUCHER WILL NOT BE ACCEPTED. NO EXCEPTIONS!!

NOTE: Only Blairstown property owners are entitled to receive these vouchers. You may pick up your vouchers beginning August 1, 2019. **Bring your tax bill and ID** to the Municipal Building during regular business hours.

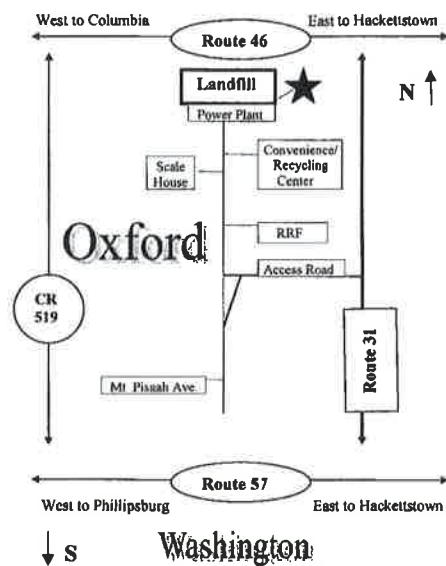

WHAT YOU CAN BRING:

Household junk
Furniture
Scrap metal
Wood
Lawn mowers (with fluid drained)
Appliances (washers, dryers, dishwashers, etc.)



DIRECTIONS TO LANDFILL:

Take Route 521 to Route 519 to Route 46. Turn left on Route 46 until you come to junction of Route 31. Turn right onto Route 31 South. In approximately one mile you will come to an access road. The sign will read Covanta Energy. Make a right onto the access road and keep to the left at the Y in the road. At the stop sign, make a right onto Mt. Pisgah Avenue and follow signs for PCFAWC Landfill.

WHAT YOU CANNOT BRING:

Hazardous waste
Truck or auto parts, including tires
Auto batteries
Explosives
Drums of any size
Asbestos
Pesticides
Liquid wastes
Gasoline
Paints (of any kind)
Computers and other electronics
Motors



**NOT INCLUDED IN CLEAN-UP
FREON-CONTAINING APPLIANCES, SUCH AS AIR
CONDITIONERS, REFRIGERATORS, FREEZERS, DE-
HUMIDIFIERS. HOWEVER, THE LANDFILL WILL
ACCEPT THESE ITEMS FOR A \$15 CHARGE PER
ITEM. DOORS MUST BE REMOVED.**

WHAT TO EXPECT AT THE LANDFILL:

- When you arrive at the scale house, you will drive onto the scale to be weighed. The attendant will take your voucher and confirm Blairstown residency and then direct you to the dumping area. Each voucher **MUST** contain the raised seal of Blairstown Township. No photo copies will be accepted—**NO EXCEPTIONS.**
- Drive to the designated area where you will unload your own vehicle.
- Children **MUST** remain in vehicles at all times—**NO EXCEPTIONS.**
- Return to the scale to be weighed out.
