MEMBER PROPER NAMES & DETACHMENT NAMES CAN NOT BE CHANGED AS THEY ARE LEGAL ENTITIES AND CAN ONLY BE UPDATED AT MCL NATIONAL OFFICE

DETACHMENT COMMANDANT REGISTRATION PROCEDURES

- 1 **CURRENT DEPARTMENT COMMANDANT & CURRENT DEPARTMENT PAYMASTER** WHO ARE ON THE CURRENT ROSTER OF INSTALLATION (ROI) IN NATIONAL HEADQUARTERS CAN REQUEST A LOGIN AT THE DEPARTMENT LEVEL
- 2 **SEND DEPARTMENT REQUEST TO THE DIVISION NVC FOR VERIFICATION OF MEMBERS & DETACHMENT GOOD STANDING STATUS.** ONCE VERIFIED THE DIVISION NVC SENDS THE REQUEST TO NATIONAL HEADQUARTERS.
- 3 **DIVISION COMMANDANT** ALSO IDENTIFIES AT THIS TIME ANY CURRENT ACTIVE DEPARTMENT USES TO BE INACTIVATED ON THE SYSTEM AS A DEPARTMENT CAN **ONLY HAVE TWO VALID USERS**
- 4 **DIVISION NVC FORWARDS TO NATIONAL HEADQUARTERS: J D FOSTER** **JFoster@MCLeague.org**
- 5 THE **NEW REGISTERED USER** WILL RECEIVE AN EMAIL (EMAIL ADDRESS ON FILE) WITH THEIR LOGIN PROCEDURES
