

## AFTER ACTION REPORT SJVCWRT MEETING OF 9/12/13

. Treasurer's Report from Walt Schulze, who was absent due to illness:

Balance of 9/13/13 is \$4,099. Conference deposits make up \$3,840. The South Bay Round Table donated \$500 for the Cruise Conference.

. Mike reported that Ryamond was selected as the "Battlefield of the Year" by the National CW Battlefield Trust.

. Patty reported that Catherine Rehart (long time member and writer) passed away this month.

. Patty still needs volunteers for our booth at Kearney Park, Oct. 19 or 20.

. Since Walt could not present his talk on CW Railroads, I brought a DVD that I had purchased, just for such an occasion. "Rebel" by Maria Agui Carter, is the story of Loreta Janeta Velazquez, who served in the Confederate Army disguised as a male. She was born in Cuba in 1842, and was somewhat of a tomboy, so her parents sent her to a school in New Orleans to become a proper young lady. At the age of 14, she disappointed her parents by marrying an officer in the U.S. Army in 1856. They had two children, who tragically died of disease. When the war broke out, her husband resigned his commission and joined the Confederate Army. He refused her request to go with him. He was killed by a firearms accident. The distraught widow took her husband's uniform, disguised herself as a man, Henry T. Buford. and moved to Arkansas, where she recruited 236 men. She claimed to have served in the battles of 1<sup>st</sup> Bull Run, Balls Bluff, Fort Donelson, and Shiloh, where she was wounded. Her secret was discovered. Eventually Confederate authorities hired her as a spy, and she went North, sometimes dressed as a woman and other times in male disguise. There she was hired as a spy, becoming a double agent. At one point she was assigned to search for herself!

. After the war she traveled and married and was widowed again two times. In 1876 she wrote a book, <u>The Woman in Battle</u>, a story of her exploits. Jubal Early pronounced it a fraud, but historians have documented some of her story, but other events are questionable. It is probable that it is a true story with embellishments to enhance sales.
