

#### Why Should I?

Once again, it's that time of year to consider running for the Hiddenbrook Board and/or volunteering for a committee. You may be thinking, why should I do this? Getting involved in the HHOA can provide better insight into the structure and the rules of governing our neighborhood. By properly maintaining our common facilities and monitoring neighborhood curb appeal, the Board's efforts can directly affect the value of your property. The Hiddenbrook Board, with support

from its committees, is responsible for maintaining and operating the clubhouse, pool, tennis courts and surrounding grounds.

Although membership to the Hiddenbrook Swim and Tennis Club is not mandatory and requires a separate initial membership purchase and continuous yearly dues to use the facilities, the assets belong to, and are the responsibility of, the HHOA members. Homeowners should be aware and informed about what their ownership and HHOA dues pay for and how they are used.

The Association operates as a business, by members who volunteer and are elected to the HHOA Board and Committees. The five Board members are elected by the Hiddenbrook homeowners on a staggered basis to provide continuity. Elections are held at the Annual Board meeting each January. The Board meets the third Tuesday of each month in the clubhouse at 7 pm to conduct business. All HHOA members are welcome and encouraged to attend. All our committees need volunteers too. A few neighbors cannot, and should not have to, do everything; everyone should try to volunteer if possible.

#### **HHOA Board Members:**

- Collectively operate the HHOA according to our covenants and bylaws and should do so for the best interests of the entire community
- Should be dedicated to the consideration and fair treatment of all HHOA members
- Develop an understanding of the fiduciary responsibilities in managing and protecting the HHOA assets,
- Oversee operations to maintain or increase HHOA's property values,
- Participate, respect, and support the Board's collective decisions
- Impact change for improvements by getting to know neighbors and their concerns
- Foster community spirit

#### **Committee Members:**

- Support the HHOA Board to broaden the burden from a few to many
- Expand the outreach to HHOA members
- Gather more ideas for methods of improvement

- Provide more services to HHOA members
- Communicate and help resolve neighborhood concerns/issues
- Suggest ideas and support activities
- Develop stronger community spirit among our neighbors

### Garbage Pickup

Roughly 10 percent of county residents receive garbage pickup service from the county. This includes the Hiddenbrook community. Pickup occurs weekly on Thursday. The pickup entails garbage, recycling, and yard debris.

The county advised there is a delay in pickup. Over the last few weeks, the delays centered on yard debris. Most recently residents even noticed a delay in pickup of recycling, which was then picked up the very next day.


Residents can go to the Fairfax County website [Special Pickup | Public Works and Environmental Services (fairfaxcounty.gov)] to review current updates/announcements on makeups, where the county noted a staffing shortage which is causing the pickup delays. In addition, the county requests that residents continue to place the yard debris on the curb until such time crews are available to pick it up.

With all of that said, below are a few reminders about trash pickup, placement, etc.

All residents can request bulk pickup of trash with the county. Residents requesting bulk pickup must coordinate in advance with the county and have 5 free collections per year. The bulk pickup can include large yard debris, electronic waste, metal, and freon. There are a few guidelines regarding special pickups. Those are outlined below.



- When you schedule your Special Pickup you will see a confirmation page with the scheduled date.
- Set out items by 6 a.m. on the collection day.

#### What

- Different trucks collect different types of materials. Piles should be separated by type (just brush or just metal, not mixed).
- Maximum 2 cubic yards of material (a pile about 6 feet long x 3 feet deep x 3 feet high). There will be a charge for piles greater than 2 cubic yards.
- See list of Accepted Materials. Any items not on this list will not be collected.
- Items must be less than 6 feet long.

#### Where

- Set your items out at the curb/street line.
- If materials are placed at a location other than the curb of your address (around the corner or across the street), include instructions in the comments field of the online form.
- For safety reasons, there must be a 20 ft. clearance above and on all sides of special collection materials.
- Do not place items under utility wires or tree branches.

The County is not responsible for items not intended for collection that are placed near the Special Pickup pile or for damage to or loss of personal trash containers.

Per the county, there are specific guidelines for placement of yard debris as well. This includes not placing yard waste in plastic bags. The county will NOT pickup the yard debris otherwise.



Yard waste is the organic waste generated by yard and lawn care and includes leaves, grass trimmings, shrub and tree trimmings. Yard waste does not include soil, mulch, sod, stumps, whole trees, large branches or limbs or clean-up from storm damage.

From March 1 – December 24, yard waste must be placed at the curb separately for collection. Yard waste must be placed in compostable paper bags or rigid containers. Yard waste set out in plastic bags may not be collected. Small quantities of yard waste can be tied

in bundles (no longer than 4 feet in length, and no more than 50 pounds in weight). Branches must not exceed 6 inches in diameter. More than 4 bundles of tied yard waste should be scheduled for a Special Pickup.

## Moreover, the county has helpful guidelines on what is recyclable and what is not recyclable.





Glass is no longer accepted in curbside recycling bins. Glass breaks during the collection process, damages sorting machinery, and reduces the value of other recyclable material in single-stream recycling. Please bring glass bottles and jars to purple, glass-only recycling containers located throughout the area. The collected container glass will be recycled for use in county projects and other beneficial applications. If you choose not to bring your container glass to a purple can, please place your glass in the trash. Some things should never be placed in the curbside recycling bin. Plastic bags can be returned to grocery stores, and clothing, shoes, and small appliances can be donated.



Some things are recyclable but not in the curbside bin program. The *I-66 transfer station* in Fairfax and the *I-95 landfill complex* in Lorton accept phones and electronics, paint, batteries, household hazardous waste, scrap metal, cooking oil, motor oil, and much more. Proper disposal of this material protects collection workers and the environment.


