## Minutes of May 6, 2019

The Huntington Township Trustees met in regular session at 7:00 PM at the Township Hall. Meeting called to order with the pledge of Allegiance by Jed Lamb. Also present were Walter Rollin, Robert Holmes, Dennis Finkel, Dimitri Szynal, Ernest Hartman, Frances Rollin and Sheila Lanning.

*Motion* by Holmes with a second by Rollin to approve the minutes of April 15, 2019 regular scheduled meeting as written. Roll call: 3 yeas.

**PAYMENT LISTING:** Checks 8663- 8689 and expenditures totaling \$14,018.77 approved for payment.

**FINANCIAL REPORT:** *Motion* by Rollin with a second by Holmes to approve the April Financial Report with year to date revenue of \$187,702.91, year to date expenditures of \$93,682.74 and bank balance of \$367,031.50. Roll call: 3 yeas. Received the Health District proposed 2020 Budget of \$1,017,487.00.
