Divisions:

Preteen Division (12 yr and under)

Teen Division (13-18 yr old)

Open Division (any age)

*In cases where the act consists of a group of people, choose the division that is appropriate for the majority of the group members.

*Accompanists, when not part of the act, may be any age.

Eligibility:

The contest is open to all amateur entertainers. Professionals are not permitted to compete. This includes Union musicians and anyone whose principle source of income is from their talent. Compensation for performing at weddings and etc. does not constitute principle source of income. There is no fee to enter the contest. Each act may appear only once (an act is defined as the same person or configuration of people). Contestants or at least one member of a group act must live in Lake County or School District #381 area to be eligible to participate in the contest.

Past Winners:

Contestants who have participated in talent contests at a county fair in the past may compete again. If a contestant previously won the Minnesota State Fair County Fair Talent Contest, they may not compete again in the same division. Former Teen Division first place winners are required to compete in the Open Division. Past Preteen first place winners must also compete in the Open Division if they are not of age to compete in the Teen Division.

Accompaniment:

Vocalists may use recorded accompaniment, provided it contains instrumental accompaniment ONLY; absolutely no vocals are allowed on the recording. For vocal acts, contestants will be disqualified if accompaniment recording has vocals of any kind. For recorded accompaniment, a CD is required. Please make sure your CD works in a CD player and not just on your computer.

Judging:

Judges' decisions are final and scores will not be released to contestants or public, though a comment sheet can be provided after the fair to those who request one.

Contestants will be judged on:

*Quality of performance (including selection)

*Stage Presence

*Entertainment Value

Please keep in mind that the Lake County Fair is a family fair. Participants are encouraged to choose an act that is age appropriate in regards to content and costuming. The Lake County Fair Board reserves the right to stop any act that is deemed inappropriate.

Sound:

If a sound system is required, all contestants are required to use the sound system provided by the Lake County Fair. The Fair will also provide microphones and compact disc player. All other instruments and amplifiers must be provided by contestant.

Time Limit:

The time limit is four minutes and points will be deducted for contestants going over the limit. Musical groups and vocalists are allowed to perform a medley of tunes, but must remain within the four-minute time limit.

Bands/Heavy Equipment:

If you have band gear or heavy equipment to load in, you must notify us to make arrangements. Please call or email us, 218-269-4159 (Rachel) or lcasfrbrd@hotmail.com one week prior to the contest.

Stage:

Contestants will perform on the standard commercial building stage. The measurement is ft. wide x deep. Contestants are encouraged to come in costume, since changing facilities are limited.

Prizes:

First Place:\$50 Cash and Opportunity to Compete at the MN State Fair

Second Place: \$30 Cash

Third Place: \$20 Cash

The winning act in each division will be eligible to represent Lake County at the Minnesota State Fair County Fair Talent Contest, if first place winner is unable to perform the second place winner may substitute . Admission to the State Fair, transportation, meals, and lodging are the responsibilities of the winning act(s). If you place in your category, please stay near the stage after the show to have your photo taken, receive your prize(s), and get information about the State Fair Competition.
