

# **HCCPTA Betty Bull Scholarship Award**

Since 1988, the Harford County Council of PTAs has sponsored this award in honor of Mrs. Bull and her tireless and selfless efforts on behalf of children's welfare. She served during the 1950s as National PTA Legislative Chair, Maryland PTA President, Maryland State PTA Legislative Chair, President of HCCPTA, and President of the Jarrettsville Elementary PTA. She was also President of the Maryland Council on Education following World War II. She died on November 13, 1990, at the age of 86. The Harford County Council PTA continues this Award Program in her Memory.

All Harford County High School Seniors with a GPA of at least 2.0 and a valid PTA/PTSA membership from any one of the 49 Harford County PTA Schools are eligible to apply for the Betty Bull Award.

## Betty Bull Award deadline is April 1, 2013

The Harford County Council of PTA. Inc. is planning to award up to four (4) \$500.00 scholarships for the 2012/2013 school year. (The number awarded is dependent on available funding from HCCPTA membership dues.)

The purpose of this award program is to provide financial assistance to students of the Parent Teacher Student Association who are pursuing their goal toward advanced education. All Harford County high school graduating seniors are eligible. There is a stipulation that the student or a parent or guardian is a member of a PTA or PTSA in Harford County.

Applications can be secured from the High School Counselor's office and also available for download on our website, click on PROGRAMS & COMMITTEES: <a href="www.hccpta.org">www.hccpta.org</a>.

#### Eligibility:

- 1. Must be a senior in a Harford County public high school.
- 2. Must have applied and been accepted at a post secondary institution, e.g. college, technical school, etc.
- 3. Must have achieved a minimum GPA of 2.0.
- 4. A copy of the student's PTA/PTSA membership card, the parent's or legal guardian's PTA/PTSA membership card, or the signature of the President of a sponsoring PTA/PTSA only must be provided with this application.
- 5. Money awarded by the scholarship must be used for tuition, transportation, books and other associated materials, room and board to a college or technical school.

**Selection Criteria:** (Rating for Award applicants is based on a scale of 100%.)

- Goals (40%)
- Volunteer work/Extra curricular activities (30%)
- Grades (GPA counts as 10% of the final process)
- Written application (10%)
- Letters of Reference (5%)
- Financial need (5%)

#### Procedure:

- Complete the three-page application
- Verify that all material is included or being submitted

#### SUPPORTING MATERIAL REQUIRED:

- Completed three-page application form by the deadline.
- Transcript of high school credits earned, including current semester and GPA.
- Two letters of recommendation from teachers, employers, sponsor, etc. (Family members may NOT be included as references.)
- Copy of PTSA or PTA membership card or signature of only a PTSA/PTA President.



#### **Treasurer's Notes**

#### Most PTAs Don't Have Personal Property but...

All incorporated PTAs should have received, in the mail, the State of Maryland Department of Assessments and Taxation's 2013 Personal Property Return. It must be filed by the April 15 deadline after which a \$25 per month penalty may be assessed. You don't want to lose your incorporation status and have to pay another \$100 to get it reinstated. If you did not receive a Personal Property Return, it could be because your incorporation was forfeited. This occurs when a corporation fails to submit the annual Personal Property Return. To obtain instructions for the completion of this form, please contact HCCPTA Treasurer, Bruce Butz, at <a href="mailto:bb@iximd.com">bb@iximd.com</a>. You can check your incorporation status by going to <a href="https://www.dat.state.md.us">www.dat.state.md.us</a>, click on Business Data Search and then Business Entity Information.

Remember that you must submit a copy of the Personal Property Return to Maryland PTA to maintain your Standards of Continuing Affiliation. It is not necessary to submit a copy to HCCPTA

#### Avoid a black mark on the PTA name

While the treasurer is assigned the duty of being the custodian of the funds of the association and accounting for these funds, all of the officers and chairmen have a fiduciary responsibility to ensure that the PTA is maintaining proper financial records, depositing money in a timely manner, adhering to the budget and complying with all legal and reporting functions. Adhering to the policies and guidelines established by National PTA, Maryland PTA, IRS, and the State of Maryland will help to reduce or eliminate questions about the management of the PTA and its monies.

All persons handling funds and all persons signing the PTA checks are liable for the use or misuse of the funds of the PTA. Responsible fiscal management is a must in any organization.

The local PTA unit has the responsibility to be accountable to its membership for all monies. Every officer can be held liable for debts incurred by the organization. In other words, if funds are unaccounted for, bills still have to be paid. Companies can take the PTA and its officers to court to recover the money due them. Your bonding insurance might cover embezzlement if the PTA established and followed certain procedures.

#### To lessen the likelihood that this problem might occur:

- \$ Demand complete written Treasurer's reports at every meeting
- \$ Bank statements should only be sent to the school address. The president should review and sign before giving to treasurer.

  An officer without signature authority should compare the resolved bank statement with the Treasurer's report.
- \$ Establish in writing the process and individuals authorized to handle PTA funds
- \$ Absolutely implement cash control policies Establish a two signature two receipt process for exchange or transfer of funds within the PTA
- \$ Deposit PTA funds immediately upon receipt
- \$ Have two signature on every check no exceptions
- \$ Never sign a blank check
- \$ Disbursement request forms should be used and receipts required
- \$ Pay all bills by check never cash.
- \$ Most important conduct an annual audit or review of the books.

#### **National PTA Membership Year Final Dues Payment**

National PTA membership year ends March 31. Maryland PTA is currently in 3<sup>rd</sup> place in the nation of large states in memberships sold. Please make sure that any memberships that have not yet been reported to Maryland PTA are reported prior to March 31, so that they get counted by National PTA.

#### **Budget Review**

Now would be a good time to take another look at the budget to determine if there is a need for any amendments that could be taken care of at your last general membership meeting.

#### **Audit/Review Preparations**

It is not too early to be thinking about who will be performing your audit for 2012/2013. Are you willing to pay someone or a company to perform the review or will you use volunteers? Will you be able to find a person? Is it going to be done by a committee? Please see National PTA's Money Matters regarding what will need to be provided. **Did you know that you are required to submit a copy of the audit/review report along with your year-end financial report to Maryland PTA to maintain your Standards of Continuing Affiliation?** 

It is not too late to submit your reports for the 2011/2012 school year if it has not already been done.



# **HCCPTA Announces Reflection Program Winners!**

"The cultural arts are wisdom. They are mankind's commentary on the human condition — comedy and tragedy. They are insights into the anguish and ecstasy, the conflicts and triumphs, the failures and aspirations of humanity." With this statement, Mary Lou Anderson founded the National PTA's Reflections Program in 1969.

Reflections is a themed competition in the cultural arts areas of Dance Choreography, Film Production, Literature, Music Composition, Photography, and Visual Arts. Students compete in four age groups: primary (pre-k through grade 2), intermediate (grades 3 through 5), middle school (grades 6 through 8), and high school (grades 9 through 12). New this year is the Special Artists age group (pre-k through 12). This offers students who are covered by the Americans with Disabilities Act the opportunity to compete as a peer group.

The theme for 2012-2013 was "The Magic of a Moment" and this year Harford county students created and submitted 696 entries to 24 local PTAs.

The Reflections program begins in the fall of each school year at the local schools. Local PTA schools that choose to participate gather school level entries, judge them, and send up to four winners per age group and arts category to county competition in December. County judging is completed in January and up to three county winners in each arts area and age group are sent on to state competition. Maryland PTA selects state level winners by early March, and a total of 30 entries — the single best entry in each arts area for each age group — go on to National PTA competition. National winners are announced in late April.

On April 18th, an awards ceremony will be held at Patterson Mill Middle/High School to honor the County winners in the Reflections Program. Sponsored by Harford County Council of PTAs, this occasion honors the 141 winners selected from the 357 entries submitted to HCCPTA. County judges may bestow up to three Awards of Excellence and up to five Awards of Merit in each age group and arts category. County judges may additionally recognize one of the Award of Excellence entries as being an Outstanding Interpretation if the entry addressed the theme exceptionally well and was technically excellent. The 68 entries recognized with Outstanding Interpretation and Award of Excellence awards at the county level went on to competition at Maryland PTA. Please join HCCPTA in congratulating all the Harford County winners in this year's Reflections competition!

#### **Avoid Common Bylaw Pitfalls**

When it is time to review your bylaws, most people get all worked up and their eyes glaze over. Bylaws are not that scary or daunting if you just take your time and avoid some common pitfalls. And now, Maryland State PTA has developed a new set of bylaws, which take effect February 12, 2013, that are very "user friendly."

The most common mistake people make is by trying to change the standard form language. Bylaws are mostly boilerplate language that cannot be changed. Yet people still try to change it. This is when your bylaws will be rejected by the Maryland State PTA. Another common mistake is forgetting to fill in all the blanks. If you have left any of the blanks empty, your bylaws will also be rejected.

Make sure when you review your bylaws, you have a committee reviewing them. This helps to make sure everything is double and triple checked. That way, when you present the bylaws to your general membership, there should not be any mistakes.

There are some common things to look for. If you have more than one vice president or secretary, you must make sure to add what each person's specific duties are as the template only includes duties for one vice president and one secretary. If your terms of office are two years, you need to add whether elections for the position are in odd or even years. If the positions are only one year, this is not necessary.

When you complete the information on the back of the bylaws concerning who to contact in case there are any issues, make sure you think carefully who to use. If you are reviewing by-laws toward the end of the school year, you need to make sure you put an officer that will presumably be at the school the next year as it is likely the review may occur over the summer. If you put, for example, a President who is leaving the school as his or her children are moving on, that person may not be available anymore to handle any questions the Maryland State PTA Bylaws Committee may have. Instead put another officer that you know will be returning.

As stated, the new bylaw template takes effect February 12, 2013. If you are reviewing your bylaws prior to that, you may use the old template you should have received at the beginning of the year in the Maryland PTA mailer. If your bylaws are due after February 12, 2013, you must use the new template. You will need to contact Maryland State PTA to get a template as you have to supply an original and not downloaded version to them. You will also need to include a copy of the minutes from the meeting in which your PTA adopted the bylaws, even if there were no changes.

When it is time to review your bylaws, don't panic! They are not as bad as you think if you just take your time and "fill in the blanks".

Representative Cathy Vitale introduced HB 232 providing that the sales and use tax not apply to sales by non-profit Parent Teacher Organizations or other non-profit organizations within an elementary school or secondary school in Maryland. Our VP for Legislation has written testimony and has been in contact with Delegate Vitale et al, the sponsors of the bill. We are asking that PTA be specifically named and that language be amended in such a way as to include our non-traditional PTAs that are not in a school building. The scheduled hearing date for the bill is February 26th at 1:00 p.m.

We are requesting that you ask your locals to go to <a href="www.mdpta.org">www.mdpta.org</a> and click on Capwiz. They will find a letter already drafted for them. All they have to do is enter their school and their information and it will be directed to their appropriate legislators.

Passage of this bill would make the monies collected in our fundraisers exempt from sales and use tax.



## **State Legislative News**

HB 532 - State Board of Education - Online Courses - Graduation Requirement (Crossfiled with SB 537)
This bill requires that students entering the 9<sup>th</sup> grade beginning the 2015-2016 School year be required to take an online course as a graduation requirement. The online course must be approved by either the Maryland State Department of Education or a local board of education. The hearing for this bill was heard before the House Ways and Means Committee on Wednesday, February 20 at 1:00 pm. Effective, Oct. 1, 2013.

#### HB 657 Truancy Education Program - Parents and Guardians of Students

This bill makes a person guilty of a misdemeanor if that person induces, attempts to induce, employs or harbors a child and causes that child to be absent unlawfully from school. The bill also imposes fines and or imprisonment for those who legally care for a child and fails to see that the child attend school. Finally the bill establishes mandatory participation in the Truancy Education Program and requires that the Pupil Personnel Service Workers of each county implement the program for parents and guardians of students who are chronically truant in the county. The bill further details requirements of the program. The hearing for this bill was heard before the House Ways and Means Committee on February 20th at 1:00 pm. Effective July 1, 2013.

#### HB 844 Public School Teachers - Certification - Continuing Education (Crossfiled with SB 694)

This bill requires each county board of education to establish continuing education criteria for certificated public school teachers and to implement a system for verifying completion of the continuing education requirements. This bill authorizes the criteria to include college course credit, leadership roles, preparation for National Board Certification or monetary grants, professional development, coaching, advising, or sponsoring extracurricular activities, and school-related community service; etc. The hearing for this bill will be on Wednesday, Mar. 6<sup>th</sup> at 1:00 pm before the House Ways and Means Committee. Effective, Oct. 1, 2013

#### HB 1069 Education - Beginning of the School Year - After Labor Day

This bill prohibits public schools and publicly funded kindergarten programs from opening for pupil attendance the day before Labor Day. The hearing for this bill was on Tuesday, Feb. 27<sup>th</sup> at 1:00 pm before the House Ways and Means Committee. Effective July 1, 2013

# HB 1168 State Department of Education - Minority Teacher Recruitment - Study and Report (Crossfiled with SB 548)

This bill requires the State Department of Education to study and make recommendation on strategies to increase and improve minority teacher recruitment, preparation, development and retention, in elementary and secondary education in the State. Requires the Department to submit a specified report to the Governor and the General Assembly on or before December 1, 2013. The hearing for this bill will be on Tuesday, Mar. 6 at 1:00 pm before the House Ways and Means Committee. Effective on July 1, 2013.

HB 229 State Aid for Public Education - Certification of Net Taxable Income (Crossfiled with SB 277)
This Administration bill requires State education aid formulas that include the local wealth component to be calculated twice; once using a net taxable income (NTI) amount for each county based on tax returns filed by September 1 and once using an NTI amount based on tax returns filed by November 1. Each local school system then receives the greater State aid amount of the results from two coagulations. Phases in the increased State aid over a five-year period, beginning fiscal 2014. The hearing for this bill was on Wednesday, Feb. 13 at 1:00 pm before the House Ways and Means committee. Effective July 1, 2013.

#### HB 684 Tobacco - Free Schools Act

This bill prohibits an individual from using a tobacco product at any time inside a school building or a bus. During regular school hours, an individual is prohibited from using a tobacco product on school grounds. Outside of regular school hours, an individual is prohibited from using a tobacco product on school grounds when children are younger than 18 are present. An employee or volunteer of a local school system, a public charter school or a private school is prohibited from using tobacco products at an off-campus, school-sponsored event in the presence of students. An individual who violates the bill must receive a warning and verbal notification of the policy for a first offense, and is subject to a civil penalty of a \$100 for each violation for a second or subsequent offense. The Maryland State Department of Education must adopt regulations to implement the bill. The hearing for this bill was on Wednesday, Feb.  $20^{th}$  at 1:00 pm before the House Ways and Means Committee. Effective July 1, 2013.

#### HB 933 Crimes - Human Trafficking of a Minor - Defense of Ignorance of Victim's Age

The bill establishes that a person charged with human trafficking of a minor may not assert a defense that the person did not know the age of the victim. The hearing for this bill was on Tuesday, Feb. 27 at 1:00 before the House Judiciary Committee. Effective Oct. 1, 2013.

#### HB 875 Education - Public Schools - Parent Trigger

This bill authorizes parents and legal guardians of students attending public schools that are not meeting State accountability goals to petition county boards of education to implement interventions. It requires county boards to notify the State Superintendent of Schools and the State Board of Education on receipt of petitions and of the final dispositions regarding the petitions; etc. This bill was heard on February 27<sup>th</sup> at 1:00 pm before the House Ways and Means Committee. Effective Oct. 1, 2013.

#### HB 396 Criminal Law - Electronic Harassment of a Minor

This bill prohibits a person from using a computer or a computer network from the following: 1) to cause a minor or another person to reasonably fear for the safety of a minor; 2) to engage in conduct which would constitute sexual harassment of a minor; 3) to disseminate data with the malicious intent to psychologically torment or harass a minor; 4) from making a any statement intended provoke or likely to provoke a third party to stalk or harass a minor. The hearing for this bill will be on March 7<sup>th</sup> at 1:00 pm before the House Judiciary Committee. Effective, Oct. 1, 2013.

#### HB 843 State Board of Education - Financial Literacy Curriculum - Graduation Requirement

This bill requires the State Board of Education to develop curriculum content for a semester long course in financial literacy. Each local board of education must implement the curriculum in every high school under the board's jurisdiction, and a student must complete the course in order to graduate from high school. The hearing for this bill will be on Wednesday, Mar.  $13^{th}$  at 1:00 pm before the House Ways and Means Committee. Effective Oct. 1, 2013.

#### HB 1123 Public Schools and Youth Sports Programs - Girls Lacrosse - Protective Head Gear

This bill requires the State Department of Education to require specified girls lacrosse youth sports programs to require specified athletes to wear protective head gear during practices and games. The bill also requires a recreational athletic organization that operates a girls lacrosse youth sports program to require specified athletes to wear protective head gear during practices and games; requiring a local government to provide a specified notice to operators of a girls lacrosse youth sports program under specified circumstances; etc. The hearing for this bill will be on Wednesday, Mar. 13<sup>th</sup> at 1:00 pm before the House Ways and Means Committee. Effective Oct. 1, 2013.

#### HB 855 Student Health and Fitness Act

This bill requires that a public school student in elementary school be provided a daily program of physical activity totaling at least 150 minutes of physical activity each week, including at least 90 minutes of physical education. It also requires that the program of physical activity for a specified category of student be consistent with a specified plan for the student. Requires public elementary schools to designate a physical activity leadership team to plan and coordinate specified activities; etc. The hearing for this bill will be on Wednesday, March 13th at 1:00 pm before the House Ways and Means Committee. Effective Oct. 1, 2013.

#### HB 232 Sales and Use Tax - Exemption - Parent-Teacher Organizations Fundraisers

This bill exempts from the state sales and use tax made by nonprofit parent-teacher organization or other nonprofit organization within an elementary or secondary school in the State. This bill was heard on Monday, Feb. 26<sup>th</sup> at 1:00 pm before the House Ways and Means Committee. Effective July 1, 2013.

#### News for members with kids:

Recent Maryland Law Enacted for Child Consumer Protection - The first in the nation.

As of January 1, 2013, parents and legal guardians can place a security freeze on their minor child's credit records that would prevent identity thieves from opening credit accounts in the child's name.

If the child has a credit record, the new law allows a parent to freeze the child's credit record so that someone seeking to open new credit in the child's name cannot access the credit report.

If the child does not have a credit record, the parent may request that a credit reporting agency create a record that prohibits the agency from releasing information about the child to potential creditors. Similarly a guardian may place a freeze on the credit record of an individual under their care.

Parents or guardians may contact the three major credit reporting agencies (Equifax, Experian, and TransUnion) to place a freeze. You can also submit a freeze request online on behalf of a minor.

#### NEWS FROM THE MARYLAND STATE DEPARTMENT OF EDUCATION

In light of traumatic brain injuries at both the professional and collegiate sports, the following information is put forth within an Education Bulletin by the Secretary of the Maryland State Department of Education, Dr. Lillian Lowery. The Maryland State Board of Education is seeking to strengthen protections for student-athletes by making permanent the emergency regulations put in place last fall requiring training for coaches in the area of brain injuries. In mid January, the State School Board members proposed requiring refresher concussion training for coaches on a biennial basis; requiring concussion training for physical education teachers; and making certain that local school systems implement policies to ensure appropriate academic accommodations, documented oral and written notification to parents, and timely notification to athletic directors and school nurses of student-athletes who have sustained a suspected concussion. The Board will publish the revised proposal in the

Maryland Register in the coming weeks. When published, the public will have an opportunity to provide public comment prior to adoption. For further details regarding the proposed amendments to current regulations please visit:

# MARYLAND SETS MODEL POLICY TO AWARD WORLD LANGUAGE CREDIT FOR STUDENTS WHO LEARN LANGUAGE OUTSIDE CLASS

#### LOCAL SYSTEMS ENCOURAGED TO DEVELOP OWN POLICIES

#### BALTIMORE, MD (January 29, 2013)

The Maryland State Board of Education, recognizing that Maryland's diverse student population has opportunities to develop language skills outside the classroom, has approved a model policy to award world languages credit for proficiency.

Local school systems may use the policy to develop policies and procedures to award credit toward high school graduation based on demonstrated proficiency.

"One of the most valuable skills immigrants bring to our country is their knowledge of foreign languages," said State Sen. James Rosapepe. "Today, Maryland is taking the lead in helping immigrants and the children of immigrants keep their heritage language skills as they perfect their English. By awarding high school credit for language skills learned at home, in churches, temples, and mosques, as well as in private, community schools, Maryland has created incentives for even more students from immigrant families to become multilingual -- a huge economic benefit for our economy and our country."

Sen. Rosapepe, along with State Del. Joseline Pena-Melnyk, spearheaded legislation that led to the *Task Force for the Preservation of Heritage Language Skills in Maryland*, established by the Maryland General Assembly in 2008. The Task Force investigated current language preservation efforts and developed new strategies in preserving world language skills in our State. The legislation creating the Task Force recognized that "while it is important for new Americans to learn and master English, there is also a critical shortage of Americans proficient in languages other than English." The bill recognized that Maryland's heritage language speakers "comprise a valuable and vastly underutilized linguistic resource."

One of the recommendations of the Task Force's January 2009 Report to the Governor and General Assembly was to "support and promote the awarding of high school credit by exam for students who attend non-public heritage language schools in Maryland."

Identifying an assessment for the awarding of credit by examination is often a challenge. To that end, MSDE convened a statewide validation and standard setting study with key stakeholders and world language experts to select the assessments and set the recommended proficiency levels equated to high school credit that are included in the model policy.

Producing internationally literate graduates – graduates who are culturally aware and proficient in languages other than English – is viewed as critical to U.S. security and to global collaboration and competition. The model policy enables students to further their study of languages and achieve advanced levels of proficiency.

#### National PTA Endorses Mental Health in Schools Act of 2013

ALEXANDRIA, VA. (January 31, 2013) - The following statement can be attributed to National PTA(r) President Betsy Landers:

National PTA supports the Mental Health in Schools Act of 2013 introduced by U.S. Senator Al Franken (D-MN). National PTA believes that all children and youth have the right to mental health support services. Democratic Congresswoman Grace F. Napolitano (CA-32) plans to introduce the House version of the bill next week, and we commend the Congresswoman and Senator Franken for championing a proposal to improve access.

The Mental Health in Schools Act would establish a grant program to help school districts form innovative community partnerships and train school staff, volunteers, families, and other members of the community to recognize the signs of child and adolescent behavioral health problems and refer them for appropriate services. Research affirms that these types of family-school partnerships and healthy home, school, and community settings contribute to positive learning environments and positive outcomes.

National PTA believes this, in addition to gun violence prevention legislation, is another significant step toward ensuring the safety of all students. The time for legislative action to improve access to mental health supports in our nation's schools is now, and we urge enactment of the Mental Health in Schools Act of 2013.
