

Day #1 ~ Duluth Aquarium, Superior Shores Tuesday August 14, 2018

This is the perfect time to get away and escape to the North Woods for a fun and relaxing end of summer vacation! Duluth, Minnesota is located on the southern shores of Lake Superior, the largest fresh water lake in the world. Upon arrival in Duluth we will visit the **Great Lakes Aquarium**. Live animal displays, hands on exhibits and a knowledgeable marine biologists staff make this visit a great experience. Duluth will be our home for the next two nights at the historic **Harbor Front Hawthorne Suites Hotel**. We enjoy a **Welcome Dinner** this evening along the harbor front. **(D)**

Ðay #2 ~ Skyline Ðrive, North Shore Rail, Gooseberry Falls, Ðinner Cruise

Wednesday August 15, 2018

A continental breakfast is included this morning and then we depart for an exciting day of scenic touring. We begin the morning with a **Duluth riding tour along Skyline Drive** where there will be some incredible views of the city as well as Lake Superior. Next we board the **North Shore Railroad** for an incredible ride along the north shores to Two Harbors. A special lunch is included at Superior Shores Resort. After lunch, we travel the short distance along the Lake Superior North Shores to the **Split Rock Lighthouse.** One of Minnesota's best known landmarks, this restored site offers a glimpse into lighthouse life from 1910-1969 in this remote and spectacular setting. On our return to Duluth, we make a short stop at **Gooseberry Falls State Park** to view the unique cascading waterfalls. This evening we enjoy a memorable viewing of the harbor lights and city of Duluth skyline. **(C.B. – L)**



Day #3 ~ Bayfield, Rittenhouse, Apostle Island Cruise Thursday August 16, 2018

Following an included **continental breakfast**, we bid farewell to the city of Duluth and travel around Lake Superior for our next featured Lake Superior city, Bayfield. Enjoy the scenery aboard your luxury motorcoach this morning as your Tri-State Travel Tour Director shares history and tales of the area and beautiful Lake Superior. Our first stop will be the Wildlife Center and Preserve for an in-depth view of the unique wildlife of the area. Lunch will be at your leisure before we travel into the North Woods of Minocqua, Wisconsin. After checking into our local hotel for our overnight accommodations, we depart for a hearty dinner at Paul Bunyan's Logging Camp! Enjoy a family-style meal in the cozy atmosphere of a logging camp complete with red checkered tablecloths and lots of mm-good home cooking! Following dinner we return to the North Woods to enjoy a wonderful theatrical production at the Northern Lights Playhouse.
