5. Chairperson and committee reports

Jim Scharl from Wisconsin Lake & Pond attended. Service work on the aerators and blowers was performed in May. Forty of the forty-two blowers were found and serviced. The lake plant survey was completed. Some native plant species were observed returning to the lake. Algae bloom driven by early rains and lack of additional flushing rains. Phosphorous control is going to be looked into.

Metcalf Prairie: Work has continued to remove invasive species of plants.

Reynolds Park: There are two dying trees at the intersection of Swan Court & Virginia Street. We plan to remove them this fall or early 2025. The Town of Excelsior & the Lake Virginia Management District will share the cost of the removal of the trees & stumps.

Toeder Park: There are a few dead trees along the perimeter of the park. The plan is to remove them and possibly other dead trees within the park. The compost area will continue to operate and be maintained as long as there is room for compost to be placed in the two designated areas. If space runs out, the compost area will be closed. We plan to order another batch of trees and expand the tree planting area along with replanting some trees in 2025.

Dam & Lake: At its peak in the summer, the water was down $10 \,\%$ ". As of 9/13/24, the water was down $17 \,\%$ ". There are suspected beaver dams downstream of the lake, backing up water into the drain pipe and toe drains. This will be investigated and a plan to fix the issue will be pursued. The Lake District has been given permission by property owners to research and address the issue. If there are beavers that need to be removed, we will contract out the work and the Lake District will cover the cost.

6. Review and possible approval – Ayers Engineering Spillway Repairs

Both repair options were presented and discussed. The second option which requires lowering the lake level was determined to be the best approach.
